

National Crime Victims' Rights Week

April 18- April 24, 2010 is National Crime Victims' Rights Week (NCVRW). This is a time for victim advocates and our communities to learn about victimization, reflect on the cost of crime to our society, and promote laws, policies, and programs to help victims of crime rebuild their lives. The 2010 NCVRW theme is "Crime Victims' Rights: Fairness. Dignity. Respect.". As described in the NCVRW toolkit, "the 2010 NCVRW theme, 'Crime Victims' Rights: Fairness. Dignity. Respect.' recalls the ideals that inspired the victims' rights movement and the laws, services, and awareness we seek to build and promote. These basic human rights, particularly crucial in times of crisis, resonate with victims, service providers, and all the visionaries who helped make these ideals a reality."

NCVRW Toolkit

As providers of services to crime victims you may have received the NCVRW toolkit from the Office for Victims of Crimes. The toolkit con-

tains ideas and materials for raising awareness of victims rights and planning NCVRW events. It can be found at <http://ovc.ncjrs.gov/ncvrw2010/welcome.html> Included in the 2010 toolkit is a DVD which contains a broadcast-ready PSA, radio PSA, and an audio clip of an officer reading the Miranda Warning. The toolkit also provides statistics on victimization and information on the history of crime victims' rights in our nation. The toolkit can serve to strengthen presentations, educate our communities, the statistics can aid in grant writing, and the toolkit tells the story of victimization and victims' rights nationally.

Partnerships and Collaborations

Gila County
