Community Coalitions –

Through funding from the Governor's Office for Children, Youth and Families and the Arizona Parents Commission on Drug Education and Prevention, tribal and county level Community Coalitions were developed and expanded to address the impact and consequences of the use and production of methamphetamine at the local level. Coalitions from Arizona's 15 Counties and six Indian Tribes participated in the 2006 Arizona Methamphetamine Conference. The Salt River Pima-Maricopa Indian Community and the Fort McDowell Indian Community are also participating as part of the Northeast Valley Coalition. The Governor's Office continues to provide support and technical assistance to community coalitions.
