## Child Crisis Arizona *Advocacy/Direct Services*

Into its fifth decade, CCA continues to actualize its doctrine of “Safe kids. Strong families.” The merging of emergency shelter services and preventative measures allows CCA to not only support victims during the most strenuous times, but to also pursue a world with fewer victims. CCA’s team focuses on child abuse prevention, intervention, and early childhood education. Their prevention programs equip parents with the knowledge and skills to properly care for youth. CCA’s intervention services consist of an emergency children’s shelter, a group home, counseling services, and foster care and adoption programs. CCA goes beyond providing a service by putting an emphasis on each individual child’s needs and working on ways to achieve long-term results. When the Arizona Department of Child Safety removes a child from the home, CCA becomes a safe home away from home for the child in distress and addresses all needs they may have as a result of their trauma. In addition, they also enroll children in school and provide them with tutoring to regain normalcy in their lives. Their approach in facilitating victim healing has helped over 35,000 children. CCA demonstrates their extraordinary care for the well-being of victims and perseverance in their lives as a symbol of acceptance, recovery, and home.

## Skye Steele, StreetLight USA *Service Coordination*

Skye is the productive visionary and CEO of StreetLightUSA. Skye has spent close to two decades being an instrumental force in developing new programs to serve victims. Prior to her time at StreetLightUSA, she was occupied with founding the Phoenix Dream Center’s Human Trafficking Program and forming their Clinical Services Department, Women’s Development Program, and Youth Development Program. At StreetLightUSA, Skye is credited with revolutionizing the way human trafficking victims are served today. Utilizing her passion to make a change and her extensive background in Psychology,

she incorporated neurosensory modulation tactics into the program’s group and behavioral health homes. Another area in which Skye has had great coordinative success is with operationalized trauma informed care in the high school setting. Skye forged a trauma informed high school exclusively tailored to survivors of human trafficking. An on-site crisis counselor, specially trained teachers, flexible schedules, and more have contributed to the success of Steele’s approach, with outcomes improving by over 70%. Furthermore, she has formed partnerships with other providers in the valley to put her “relationship is the intervention” belief into fruition. Skye has achieved remarkable success in recognizing and acting upon barriers trafficking victims face in recovery.

Cindy Woods is the Victim Compensation Advocate of five years for the Mohave County Attorney's Office. Cindy demonstrated her innovative skills and initiative while helping a family after an immense tragedy in 2019. Cindy noticed a cry for help when a local high school senior passed away in a tragic boating incident on Lake Mead. With friends of the victim's family calling out to the community for support, Cindy wanted to take action and made a persistent effort to contact the family. She utilized the modern power of social media to make this effort to reach out a hand to a family in need. Her efforts were successful

and soon enough she was able to employ the Mohave County Victim Compensation Program to assist the family with expenses related to the tragedy. Woods success was achieved through a true passion for ensuring that victims are served no matter what, as this case was not even in her jurisdiction. Cindy Woods is respected and trusted by those around her to exhibit her compassion for victims by any means necessary, and she remains unafraid to exercise the unconventional.

Through her vision, she has been able to actualize accessible and free trauma counseling for victims, create the VA Patrol Unit to assist victims around the clock, and make it possible for victims to petition the Glendale City Court for an OOP/IAH at alternative locations convenient to their needs. These positive changes illustrate her true empathy for vic-

tims and her visionary leadership that allows her to produce such significant outcomes. Melissa has also created a safe place for victims to feel at ease in the Glendale Family Advocacy Center to include Oliver, the Center's diligent emotional support dog. She is frequently called upon by other agencies looking to model their programs after Glendale's admirable Victim Assistance Unit. Melissa continues to play an active role in bettering the lives of crime victims and sets the precedent for being an exemplary leader in her field.
