Pursuant to the Court's Order of June 6, 2013, granting a joint motion brought by the Special Fiduciary, the Utah Attorney General's Office, and the Arizona Attorney General's Office (the "Moving Parties"), the Court received and has carefully reviewed each of the applications filed by individuals seeking appointment to a Board of Trustees for the United Effort Plan Trust (the "Trust"). In connection with the Moving Parties, the Court will arrange travel to St. George or other


convenient location to interview those candidates residing in Southern Utah/Northern Arizona. Salt Lake-based applicants will be interviewed in Salt Lake City.


