The complainant herein personally appears and, being first duly sworn, complains (of his own knowledge) (on information and belief) against: **SYLVIA NEREY**, D.O.B 3/5/1966 charging that in Precinct One, Santa Cruz County, Arizona:

#### COUNT 1 FRAUD

On or between the 1<sup>st</sup> day of October 2006 to the 31<sup>st</sup> day of October, 2008, in the County of Santa Cruz the Defendant, SYLVIA NEREY, pursuant to artifice to defraud, knowingly obtained a benefit from scheme or the SOUTHEASTERN ARIZONA BEHAVIORAL HEALTH SYSTEMS. INC (SEABHS), by means of fraudulent pretenses, representation, promises, or material omissions, in violation of A.R.S. §§ 13-2310, 13-302, 13-701, 13-702, and 13-801, a class 2 felony.

Said conduct occurred when she defrauded her employer, Southeastern Arizona Behavioral Health Systems, Inc. by creating eighteen (18) fraudulent checks and either depositing them or cashing them into her personal account(s).

#### COUNT 2 THEFT

On or between the 1<sup>st</sup> day of October 2006 to the 31<sup>st</sup> day of October, 2008, in the County of Santa Cruz the Defendant, **SYLVIA NEREY**, knowingly controlled funds and/or checks and/or property belonging to SOUTHEASTERN ARIZONA BEHAVIORAL HEALTH SYSTEMS, INC., of a value of \$25,000 or more with the intent to deprive SOUTHEASTERN ARIZONA BEHAVIORAL HEALTH SYSTEMS, INC., of such property, in violation of A.R.S. §§ 13-1802(A)(1), 13-1801, 13-302, 13-701, 13-702, and 13-801, a class 2 felony.

Said conduct occurred when she knowingly controlled funds in the amount of \$30,665.72 belonging to SOUTHEASTERN ARIZONA BEHAVIORAL HEALTH SYSTEMS, INC. with the intent to permanently deprive.

## COUNT 3 FORGERY

On or about 31<sup>st</sup> day of October, in the County of Santa Cruz, Arizona, **SYLVIA NEREY**, with intent to defraud, falsely made, completed or altered a written instrument or offer or presented, whether accepted or not, a forged instrument or one which contains false information in violation of A.R.S. §§ 13-2001, 13-2002, 13-302, 13-701, 13-702, and 13-801, a class 4 felony.

Said conduct occurred when SYLVIA NEREY presented a forged check in the amount of \$975.99 and either deposited or cashed said check into her personal account(s).

# COUNT 4

## FORGERY

On or about 31<sup>st</sup> day of October, in the County of Santa Cruz, Arizona, **SYLVIA NEREY**, with intent to defraud, falsely made, completed or altered a written instrument or offer or presented, whether accepted or not, a forged instrument or one which contains false information in violation of A.R.S. §§ 13-2001, 13-2002, 13-302, 13-701, 13-702, and 13-801, a class 4 felony.

Said conduct occurred when SYLVIA NEREY presented a forged check in the amount of \$989.75 and either deposited or cashed said check into her personal account(s).

On or about 31<sup>st</sup> day of January, 2007, in the County of Santa Cruz, Arizona, **SYLVIA NEREY**, with intent to defraud, falsely made, completed or altered a written instrument or offer or presented, whether accepted or not, a forged instrument or one which contains false information in violation of A.R.S. §§ 13-2001, 13-2002, 13-302, 13-701, 13-702, and 13-801, a class 4 felony.

Said conduct occurred when SYLVIA NEREY presented a forged check in the amount of \$1,159.96 and either deposited or cashed said check into her personal account(s).

## COUNT 7

On or about 6<sup>th</sup> day of March, 2007, in the County of Santa Cruz, Arizona, **SYLVIA NEREY**, with intent to defraud, falsely made, completed or altered a written instrument or offer or presented, whether accepted or not, a forged instrument or one which contains false information in violation of A.R.S. §§ 13-2001, 13-2002, 13-302, 13-701, 13-702, and 13-801, a class 4 felony.

Said conduct occurred when SYLVIA NEREY presented a forged check in the amount of \$768.22 and either deposited or cashed said check into her personal account(s).

## COUNT 8 FORGERY
