**COUNT 1: COMPUTER TAMPERING,**  
a Class 6 Felony, in violation of A.R.S. § 13-  
2316 (A)(8),

**COUNT 2: UNAUTHORIZED ACCESS  
TO CRIMINAL HISTORY,** a Class 6  
Felony, in violation of A.R.S. § 41-1756  
(A)(2),

**COUNT 3: COMPUTER TAMPERING,**  
a Class 6 Felony, in violation of A.R.S. § 13-  
2316 (A)(8),

**COUNT 4: UNAUTHORIZED ACCESS  
TO CRIMINAL HISTORY,** a Class 6  
Felony, in violation of A.R.S. § 41-1756  
(A)(2),

**COUNT 5: COMPUTER TAMPERING**, a Class 6 Felony, in violation of A.R.S. § 13-2316 (A)(8),

**COUNT 6: UNAUTHORIZED ACCESS TO CRIMINAL HISTORY**, a Class 6 Felony, in violation of A.R.S. § 41-1756 (A)(2),

**COUNT 7: COMPUTER TAMPERING**, a Class 6 Felony, in violation of A.R.S. § 13-2316 (A)(8),

**COUNT 8: UNAUTHORIZED ACCESS TO CRIMINAL HISTORY**, a Class 6 Felony, in violation of A.R.S. § 41-1756 (A)(2).

The Arizona State Grand Jury accuses **DANIEL ALBERT CORONADO (001)**, charging this 16<sup>th</sup> day of September, 2008, that in Maricopa County, Arizona:

**COUNT 1**

**(COMPUTER TAMPERING)**

On or between January 27, 2005, and December 21, 2005, **DANIEL ALBERT CORONADO (001)**, acting without authority or by exceeding his authorization of use, knowingly accessed a computer, computer system or network, or any computer software, program or data that is contained in a computer, computer system or network, in violation of A.R.S. §§ 13-2316 (A)(8), 13-2301, 13-701, 13-702, 13-702.01 and 13-801.

**COUNT 2****(UNAUTHORIZED ACCESS TO CRIMINAL HISTORY)**

On or between January 27, 2005, and December 21, 2005, **DANIEL ALBERT CORONADO (001)**, committed unauthorized access to criminal history by intentionally, knowingly, or recklessly, using the Arizona criminal justice information system or criminal history record information for a purpose other than as provided by § 41-1750, in violation of A.R.S. §§ 41-1756(A)(2), 41-1750, 13-701, 13-702, 13-702.01, and 13-801.

**COUNT 3****(COMPUTER TAMPERING)**

On or between January 12, 2006, and December 30, 2006, **DANIEL ALBERT CORONADO (001)**, acting without authority or by exceeding his authorization of use, knowingly accessed a computer, computer system or network, or any computer software, program or data that is contained in a computer, computer system or network, in violation of A.R.S. §§ 13-2316 (A)(8), 13-2301, 13-701, 13-702, 13-702.01 and 13-801.

**COUNT 4****(UNAUTHORIZED ACCESS TO CRIMINAL HISTORY)**

On or between January 12, 2006, and December 30, 2006, **DANIEL ALBERT CORONADO (001)**, committed unauthorized access to criminal history by intentionally, knowingly, or recklessly, using the Arizona criminal justice information system or criminal history record information for a purpose other than as provided by § 41-1750, in violation of A.R.S. §§ 41-1756(A)(2), 41-1750, 13-701, 13-702, 13-702.01, and 13-801.

**COUNT 5****(COMPUTER TAMPERING)**

On or between February 17, 2007, and December 20, 2007, **DANIEL ALBERT CORONADO (001)**, acting without authority or by exceeding his authorization of use, knowingly accessed a computer, computer system or network, or any computer software, program or data that is contained in a computer, computer system or network, in violation of A.R.S. §§ 13-2316 (A)(8), 13-2301, 13-701, 13-702, 13-702.01 and 13-801.

**COUNT 6****(UNAUTHORIZED ACCESS TO CRIMINAL HISTORY)**

On or between February 17, 2007, and December 20, 2007, **DANIEL ALBERT CORONADO (001)**, committed unauthorized access to criminal history by intentionally, knowingly, or recklessly, using the Arizona criminal justice information system or criminal history record information for a purpose other than as provided by § 41-1750, in violation of A.R.S. §§ 41-1756(A)(2), 41-1750, 13-701, 13-702, 13-702.01, and 13-801.

**COUNT 7****(COMPUTER TAMPERING)**

On or between January 3, 2008, and July 12, 2008, **DANIEL ALBERT CORONADO (001)**, acting without authority or by exceeding his authorization of use, knowingly accessed a computer, computer system or network, or any computer software, program or data that is contained in a computer, computer system or network, in violation of A.R.S. §§ 13-2316 (A)(8), 13-2301, 13-701, 13-702, 13-702.01 and 13-801.

**COUNT 8****(UNAUTHORIZED ACCESS TO CRIMINAL HISTORY)**

On or between January 3, 2008, and July 12, 2008, **DANIEL ALBERT CORONADO (001)**, committed unauthorized access to criminal history by intentionally, knowingly, or recklessly, using the Arizona criminal justice information system or criminal history record information for a purpose other than as provided by § 41-1750, in violation of A.R.S. §§ 41-1756(A)(2), 41-1750, 13-701, 13-702, 13-702.01, and 13-801.

Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in MARICOPA County, Arizona.
