Dear Mr. La Sota:

I write regarding the Office's disposition of the above-referenced campaign finance Complaint concerning Heap for House's alleged failure to report five 2023 campaign finance contributions from four different Political Action Committees (PACs) in violation of A.R.S. § 16-926(B)(2)(a)(iv). While Mr. Heap's conduct in the course of the investigation was concerning, the Office has determined that Heap for House did not accept the respective contributions and therefore finds that no violation occurred, as further set forth below.

A. Background.

1. The alleged violation.

On February 28, 2024, the Arizona Secretary of State received a Complaint alleging that Heap for House had failed to report the following 2023 campaign finance contributions:

1/2/23 - \$300 - Freeport-McMoRan Inc. Arizona Political Action Committee

1/2/23 - \$500 - Pinnacle West Capital Corporation Political Action Committee

10/25/23 - \$1,000 - Realtors of AZ PAC

12/18/23 - \$500 - Realtors of AZ PAC

12/28/23 - \$250 - AZ Fraternal Order of Police PAC

These PACs reported the foregoing contributions in their respective campaign finance reports, but Heap for House reported \$0 received from PACs in 2023. After notifying Mr. Heap of the Complaint and receiving no response, the Secretary found reasonable cause to believe that Heap for House had violated A.R.S. § 16-926(B)(2)(a)(iv) and referred the matter to this Office for investigation pursuant to A.R.S. § 16-938.

2. The investigation and findings.

Initially, I note that Mr. Heap needlessly prolonged and complicated this matter through his dilatory and uncooperative conduct. The Secretary of State invited Mr. Heap to respond to the Complaint in a March 21 letter, but Mr. Heap never responded. You have asserted that "Mr. Heap never received this communication." 6/13/24 T. La Sota letter to C. Garrett. While I can't speak to that claim's veracity, your further assertion that the Secretary's "supposed 'efforts' were minimal and not truly intended to afford him actual notice" of the Complaint, *id.*, is baseless.

The Secretary directed his letter to "info@voteheap.com," the email address listed on Heap for House's February 28, 2024 Campaign Finance Report. After the Secretary referred the matter to this Office, I sent my initial correspondence to Mr. Heap at that same email address and also sent a hardcopy to the PO Box listed on the Campaign Finance Report. Again, Mr. Heap failed to respond—and he has never offered any explanation for that failure. A campaign committee agrees by law "to accept all notifications and service of process via the e-mail address provided by the committee." A.R.S. § 16-906(B)(6). And "[f]ailure to regularly check one's email will not be considered a valid defense to any enforcement action." Arizona Secretary of State, *Campaign Finance Candidate Guide* (April 2022) ("Candidate Guide"), at 4 n.16. Mr. Heap's attempts to escape accountability have therefore been concerning.

On May 22, 2024, you sent a letter to Attorney General Mayes about this matter that reflected no awareness of my prior effort to contact Mr. Heap. I answered that letter (enclosing my prior correspondence to Mr. Heap) two days later, requesting a response by June 7. After that deadline passed with no communication, I sent you a follow-up email on June 11; you acknowledged receipt of that email and then sent a responsive letter on June 13. Subsequently, you sent additional information via email.

By way of defense, Mr. Heap asserted that "Heap for House never cashed any such checks and never accepted any of these contributions." 5/22/24 T. La Sota letter to Attorney General Mayes. In support of this defense, Mr. Heap (through your correspondence) provided (1) emails from three of the PACs (Freeport McMoRan, Pinnacle West, and AZ Fraternal Order of Police) stating that Heap for House did not cash their respective checks; (2) images of voided checks from Pinnacle West and the Arizona Police Association; and (4) banking screenshots indicating that the two Realtors of AZ checks were voided. Additionally, Mr. Heap indicated that the respective PACs had either amended or intended to amend their campaign finance reports to reflect that Heap for House had not accepted the contributions they had previously reported. 6/13/24 T. La Sota letter to C. Garrett.

On June 21, I sent you follow-up correspondence noting that the voided Police Association check was from December 2022 in the amount of \$200 and that it therefore did not align with the check at issue in the Complaint. Thereafter, you sent periodic updates stating that you intended to address this issue. In August, you sent an email exchange with the Fraternal Order of Police that indicated "Heap[']s check shows voided" but that lacked specificity sufficient for me to credit it. On September 4, you sent a letter with a verification by Mr. Heap expressly stating that Mr. Heap "has not cashed or deposited any checks to his House Campaign Account since October of 2022,"

and explaining that you had provided the December 2022 voided check in error. 9/4/24 T. La Sota letter to C. Garrett. Additionally, you provided an express representation by the Fraternal Order of Police's Executive Director stating "that check #1591, written to Justin Heap on 12/28/2023 has not been cashed and has been voided on our end."

Importantly, beyond the information that Mr. Heap has provided, I have discovered through my own investigation that each of the PACs implicated in this matter has now in fact amended its campaign finance report to reflect that Heap for House did not accept their respective contributions. *See* Exhibit A. The Secretary of State's Candidate Guide defines "contributions" as "all sources of money that flow into a candidate's campaign account." Candidate Guide at 19. Given the strong evidence that Mr. Heap did not deposit the checks at issue here, the Office credits his defense that he did not receive reportable contributions.

B. Disposition.

Mr. Heap's lack of cooperation unnecessarily prolonged this investigation and disposition, wasting valuable government time and resources in the process. With that said, the question before the Office was whether Heap for House violated A.R.S. § 16-926(B)(2)(a)(iv) by failing to report five apparent campaign contributions. The Office concludes that no violation occurred and—subject to any new information that casts doubt on the exculpatory evidence underlying this conclusion—considers the matter closed.
