**SEXUAL EXPLOITATION OF A MINOR, A CLASS 2 FELONY**

On or about January 28, 2025, **ROBERT GILBERT BERGHOFER (001)**, knowingly did distribute, transport, exhibit, receive, sell, purchase, electronically transmit, possess, or exchange any visual depiction in which a minor under fifteen years of age is engaged in exploitive exhibition or other sexual conduct (to wit file named: 38e62d4e-e96e-4551-blcf-3fldcfb913c) in violation of A.R.S. §§ 13-3553, 13-3553(A)(2), 13-3551, 13-3821, 13-705, 13-701, 13-702, and 13-801.


