Lydia Linsmeier made a motion to adjourn to Executive Session pursuant to A.R.S. § 38-431.03(A)(3) to obtain advice regarding conflicts of interest. Holli Ploog seconded the motion. The motion passed unanimously. The Board adjourned to Executive Session at 11:08 a.m. and returned to the regular meeting at 11:47 a.m. No action was taken by the Board.

## **IV. Topics for Discussion and Possible Action**

### **a. Subcommittee Updates**

#### **i. Subcommittee on Hate-Based Crimes and Antisemitic Incidents**

Subcommittee Chairperson Holli Ploog reported that the Subcommittee is in the process of finalizing its report. The subcommittee will study LGBTQIA+ hate-based crimes and incidents after it completes its first report. The next Subcommittee meeting is Thursday, September 4, 2025.

## **b. Discussion and Possible Action regarding Committees and Subcommittees.**

### **i. Federal Executive Actions Committee**

Committee Chairperson Jordan Brunner reported that the Committee met on July 7, 2025 where it discussed specific federal executive orders for potential research. The Chairperson Brunner noted that the Committee may study the implication and long-term consequences of recent federal executive orders. Chairperson Brunner made a motion to change the name of the Committee to the Federal Executive Actions Committee. Matthew Capalby seconded the motion. The motion passed unanimously.

### **ii. Creation of Rural Communities Subcommittee**

Matthew Capalby noted that there are distinct concerns which impact rural communities in Arizona. In particular, there was discussion that five healthcare facilities serving rural communities are looking at closing. Matthew Capalby made a motion to create a Rural Communities Subcommittee. Holli Ploog seconded. The motion passed unanimously. Matt Capalby was nominated and selected as Chair of the Subcommittee, which was approved unanimously by the Board. Holli Ploog was nominated and selected as Vice Chair of the Subcommittee; which was approved unanimously by the Board.

The next Board meeting is scheduled for December 3, 2025. Members will receive potential dates for a special meeting in September, 2025.
