I. Call to Order

A quorum being present, Chairperson Ross called the meeting to order at 1:07 p.m. The meeting took place via Zoom.

II. Approval of September 30, 2025 Meeting Minutes

a. Updates from Working Groups

i. Data Collection Working Group

ii. Legislation and Priorities Working Group

Drew Schaffer discussed AZ Republic article showing converse relationship between the free free program and crime. Discussion regarding cities utilizing predictive analytics for policing.

b. Report from the Housing Justice Unit

Heather Hamel, Unit Chief Counsel, Housing Justice Unit reported generally on the Unit, its focus, and its litigation.

c. Housing Updates

Holli Ploog discussed a report addressing housing and homelessness in the Verde Valley region. Discussion was had regarding methodologies to attempt to address housing

instability and homelessness, including production of low-income housing, right to representation, emergency rental assistance, and rapid rehousing programs.

Leslie Ross discussed that the U.S. Department of Housing and Urban Development is currently furloughed. Individuals are seeking assistance from other sources, including the Arizona Civil Rights Division.

Tasha Lynch noted that the Southwest Fair Housing Council is currently receiving FHIP funding.

Nathan Smith discussed that the Department of Economic Security is going through a RFP process related to housing and homelessness funding.
