ROBLES (001)**, on or about April 24, 2025, knowingly did initiate, organize, plan, finance, direct, manage, or supervise the theft and trafficking in the property of Home Depot store # 467 that had been stolen, to-wit: Husky Reversible Ratcheting Wrench Set and/or Husky Mechanics tool set, in violation of A.R.S. §§ 13-2301, 13-2307, 13-701, 13-702, and 13-801.

#### COUNT 45

## ORGANIZED RETAIL THEFT, A CLASS 4 FELONY

EMILIO M. ROBLES (001) AND/OR MANUEL ROBLES (005), on or about April 24, 2025, acting alone or in conjunction with another person, did use an artifice, instrument, container, device or other article to facilitate the removal of merchandise from Home Depot store #419, a retail establishment, without paying the purchase price, in violation of A.R.S. §§ 13-1801, 13-1819, 13-701, 13-702, and 13-801.

## TRAFFICKING IN STOLEN PROPERTY, FIRST DEGREE, A CLASS 2 FELONY

**EMILIO M. ROBLES (001)**, on or about April 24, 2025, knowingly did initiate, organize, plan, finance, direct, manage, or supervise the theft and trafficking in the property of Home Depot store # 419 that had been stolen, to-wit: Milwaukee Cordless Rachet and/or Milwaukee Cordless Hammer Drill and Impact Driver and/or Gearwrench Mechanic Tool Set, in violation of A.R.S. §§ 13-2301, 13-2307, 13-701, 13-702, and 13-801.

#### COUNT 47

#### ORGANIZED RETAIL THEFT, A CLASS 4 FELONY

EMILIO M. ROBLES (001) AND MANUEL ROBLES (005), on or about April 27, 2025, acting alone or in conjunction with another person, did use an artifice, instrument, container, device or other article to facilitate the removal of merchandise from Home Depot store #481, a retail establishment, without paying the purchase price, in violation of A.R.S. §§ 13-1801, 13-1819, 13-701, 13-702, and 13-801.

#### COUNT 48

## TRAFFICKING IN STOLEN PROPERTY, FIRST DEGREE, A CLASS 2 FELONY

EMILIO M. ROBLES (001) AND MANUEL ROBLES (005), on or about April 27, 2025, knowingly did initiate, organize, plan, finance, direct, manage, or supervise the theft and trafficking in the property of Home Depot store # 481 that had been stolen, towit: Milwaukee cut off saw and/or Milwaukee Drywall rotary tool and/or Milwaukee orbit sander and/or Milwaukee drywall screw gun, in violation of A.R.S. §§ 13-2301, 13-2307, 13-701, 13-702, and 13-801.

## TRAFFICKING IN STOLEN PROPERTY, FIRST DEGREE, A CLASS 2 FELONY

EMILIO M. ROBLES (001) AND MANUEL ROBLES (005), on or about April 27, 2025, knowingly did initiate, organize, plan, finance, direct, manage, or supervise the theft and trafficking in the property of Home Depot store # 481 that had been stolen, towit: DeWalt Power Washer, in violation of A.R.S. §§ 13-2301, 13-2307, 13-701, 13-702, and 13-801.

#### COUNT 50

#### POSSESSION OF A DANGEROUS DRUG,

#### A CLASS 4 FELONY

**EMILIO M. ROBLES (001)**, on or about May 2, 2025, knowingly possessed a dangerous drug, to wit: methamphetamine, in violation of A.R.S. §§ 13-3407(A)(2), 13-3401(36), 13-701, 13-702, 13-703, 13-801, and 13-811.

#### COUNT 51

#### POSSESSION OR USE OF DRUG PARAPHERNALIA,

#### A CLASS 6 FELONY

EMILIO M. ROBLES (001), on or about May 2, 2025, unlawfully did use or possess with intent to use Baggies and/or glass pipe and/or backpack, drug paraphernalia, to plant, propagate, cultivate, grow, harvest, manufacture, compound, convert, produce, process, prepare, test, analyze, pack, repack, store, contain, conceal, inject, ingest, inhale or otherwise introduce into the human body Methamphetamine, in violation of A.R.S. §§ 13-3401, 13-3405, 13-3407, 13-3408, 13-3415, 13-3418, 13-701, 13-702, and 13-801.

### FRAUDULENT SCHEMES AND ARTIFICES,

#### A CLASS 2 FELONY

EMILIO M. ROBLES (001) AND JOSE ANTONIO CELIS PEREZ (003), on or between April 6, 2025 and April 19, 2025, pursuant to scheme or artifice to defraud, knowingly did obtain a benefit from Home Depot, by means of fraudulent pretenses, representation, promises, or material omissions, in violation of A.R.S. §§ 13-2310, 13-701, 13-702, and 13-801.

This scheme included, but was not limited to, purchasing items from Home Depot stores and retaining the receipt. Later, **EMILIO M. ROBLES (001)** AND/OR **JOSE ANTONIO CELIS PEREZ (003)**, would go to a different Home Depot store. There, they would select items matching what was purchased and go to customer service. They would present the items along with the receipt in order to obtain a refund that they were not entitled to.

#### COUNT 53

## FRAUDULENT SCHEMES AND ARTIFICES,

#### A CLASS 2 FELONY

EMILIO M. ROBLES (001) AND SAMUEL J. RAMIREZ (002) AND JOSE ANTONIO CELIS PEREZ (003) AND DIEGO AGUILAR FERNANDEZ (004) AND MANUEL ROBLES (005) AND JOSE LUIS MUNOZ (006) AND MIRNA GONZALES-ALMAZAN (007), on or between January 3, 2025 and May 2, 2025, pursuant to scheme or artifice to defraud, knowingly did obtain a benefit from Home Depot and/or ACE Hardware Stores and/or Lowe's and/or Harbor Freight, by means of fraudulent pretenses, representation, promises, or material omissions, in violation of A.R.S. §§ 13-2310, 13-701, 13-702, and 13-801.

This scheme included, but was not limited to, selecting items in the store and proceeding to a register. After scanning the items into the register, one individual would leave the store

while the remaining person would appear to be conducting a transaction with a credit or debit card. When the credit or debit card was declined, the individual inside would state they were going to retrieve the items or get another method of payment. Instead, they would leave the property without paying for the items.

#### COUNT 54

#### THEFT, A CLASS 2 FELONY

EMILIO M. ROBLES (001) AND SAMUEL J. RAMIREZ (002) AND JOSE ANTONIO CELIS PEREZ (003) AND DIEGO AGUILAR FERNANDEZ (004) AND MANUEL ROBLES (005) AND JOSE LUIS MUNOZ (006) AND MIRNA GONZALES-ALMAZAN (007), on or between January 3, 2025 and May 2, 2025, without lawful authority, knowingly did control various tools and merchandise belonging to ACE Hardware, Harbor Freight Tools, Home Depot and/or Lowes's, with a value of \$25,000 or more, but less than \$100,000, with the intent to deprive ACE Hardware, Harbor Freight Tools, Home Depot and/or Lowes of such property, in violation of A.R.S. §§ 13-1801, 13-1802, 13-701, 13-702, and 13-801.

#### COUNT 55

## ILLEGALLY CONDUCTING AN ENTERPRISE,

#### A CLASS 3 FELONY

EMILIO M. ROBLES (001) AND SAMUEL J. RAMIREZ (002) AND JOSE ANTONIO CELIS PEREZ (003) AND DIEGO AGUILAR FERNANDEZ (004) AND MANUEL ROBLES (005) AND JOSE LUIS MUNOZ (006) AND MIRNA GONZALES-ALMAZAN (007), on or between January 3, 2025 and May 2, 2025, was/were employed by or associated with an enterprise and did knowingly conduct the enterprise's affairs through racketeering or did knowingly participate directly or indirectly in the conduct of the enterprise which he knew was being conducted through racketeering. The enterprise(s) included, but were not limited to a group of persons associated in fact, including but not limited to SAMUEL J RAMIREZ (002), MANUEL

ROBLES (005), JOSE LUIS MUNOZ (006), and MIRNA GONZALES-ALMAZAN (007) and others known and/or unknown.

The racketeering included:

- 1. Theft, in violation of A.R.S. § 13-2301(D)(4)(b)(v);
- 2. Trafficking in stolen property, in violation of A.R.S. § 13-2301(D)(4)(b)(xii), which were sold and/or offered to be sold on Facebook Marketplace, a Meta Platforms, Inc. company;
- 3. A scheme or artifice to defraud, in violation of A.R.S. § 13-2301(D)(4)(b)(xx).

The alleged racketeering includes, but is not limited to the acts of racketeering described in this Indictment (which are incorporated herein by reference as if set forth in full), in violation of A.R.S. §§ 13-2312(B) and (D), 13-2301, 13-108, 13-109, 13-301, 13-302, 13-304, 13-701, 13-702, 13-703, 13-801, 13-804, 13-811, 13-2313, 13-2314.

#### COUNT 56

## CONSPIRACY, A CLASS 2 FELONY

EMILIO M. ROBLES (001) AND SAMUEL J. RAMIREZ (002) AND JOSE ANTONIO CELIS PEREZ (003) AND DIEGO AGUILAR FERNANDEZ (004) AND MANUEL ROBLES (005) AND JOSE LUIS MUNOZ (006) AND MIRNA GONZALES-ALMAZAN (007), on or between January 3, 2025 and May 2, 2025, defendants herein, with the intent to promote or aid the commission of an offense, did agree with one or more persons, both known and unknown to the State Grand Jury, that at least one of them or another person would engage in conduct constituting the offenses, in particular:

- 1. Organized Retail Theft, in violation of A.R.S. § 13-1819A1;
- 2. Trafficking in Stolen Property in the First Degree, in violation of A.R.S. § 13-2307B;
- 3. Fraudulent Schemes and Artifices, in violation of A.R.S. § 13-2310; and
- 4. Theft, in violation of A.R.S. § 13-1802.

In furtherance of this conspiracy and to affect the foregoing objects thereof, these defendants and their co-conspirators did commit numerous overt acts, including but not limited to the overt acts described in Counts 1-54 of this Indictment (which are incorporated herein by reference as if set forth in full), in violation of A.R.S. §§ 13-1003, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702 and 13-801.

Pursuant to A.R.S. § 21-425, the Grand Jurors find that the offenses described above were committed in Pima County, Arizona.
