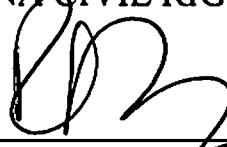

The Board reviewed the data received from the Law Enforcement Survey and discussion was held as to how best to report the data. The members will do some of the analysis individually and report back to the Board with findings and questions.
