#### **I. Call to Order**

A quorum being present, Chairperson Ploog called the meeting to order at 3:02 pm. The meeting took place via Zoom.

#### **II. Introductory Remarks**

Chairperson Ploog welcomed all members to the meeting as it is the first meeting of the year, and the first meeting of newly appointed subcommittee members to focus on hate crimes and incidents impacting the LGBTQ+ community.

#### **III. Approval of December 1, 2025 Meeting Minutes.**

Chairperson Ploog asked for any amendments or corrections to the draft minutes. With none noted, the draft minutes were deemed approved.

#### **IV. Topics for Discussion and Possible Action:**

##### **a. Discussion regarding introduction of new committee members and history of subcommittee.**

All subcommittee members present introduced themselves and the context of the subcommittee was discussed.

##### **b. Discussion regarding mission of subcommittee and potential work groups.**

Members discussed findings from the subcommittee's previous work on antisemitism including learning about challenges with law enforcement reporting of hate-based crimes and incidents as well as charging limitations. Members discussed the current landscape of legal concerns related to hate-based crimes and incidents impacting the LGBTQ+ community across multiple sectors. Members discussed a variety of approaches including development of a fact sheet about existing protections for the LGBTQ+ community, conducting community surveys, conducting community roundtable discussions. The group decided to return to this topic at the next regular meeting.
