The State Grand Jury accuses **JENNIFER ELIZABETH ALCAIDA (001)**, charging on this 14th day of April, 2025, that in or from Mohave County, Arizona:

COUNT 1

FRAUDULENT SCHEMES AND ARTIFICES, A CLASS 2 FELONY

JENNIFER ELIZABETH ALCAIDA (001), beginning or about July 23, 2021 and ending on or about September 7, 2021, pursuant to scheme or artifice to defraud, knowingly did obtain a benefit from the Town of Parker, Arizona, exceeding \$100,000, by means of fraudulent pretenses, representation, promises, or material omissions, in violation of A.R.S. §§ 13-2310, 13-701, 13-702, and 13-801.

JENNIFER ELIZABETH ALCAIDA (001), committed fraud schemes and artifices, by committing the following actions, including but not limited to: forging six check, two of which were not cashed because they were cancelled by the Town of Parker; and receiving funds after cashing check numbers 24205, 24213, 24228, 24229 which resulted in a financial loss to the Town of Parker totaling \$158,837.27.

COUNT 2

THEFT, A CLASS 2 FELONY

JENNIFER ELIZABETH ALCAIDA (001), beginning on or about July 23, 2021 and ending on or about September 7, 2021, without lawful authority, knowingly did control the Town of Parker, Arizona's funds, of a value of more than \$100,000, with the intent to

deprive the Town of Parker of such property, to wit: \$158,837.27 in cashed checks, in violation of A.R.S. §§ 13-1801, 13-1802(A)(1), 13-1802(H), 13-701, 13-702, and 13-801.

COUNT 3

FORGERY, A CLASS 4 FELONY

JENNIFER ELIZABETH ALCAIDA (001), on or about July 23, 2021, with intent to defraud, falsely made, completed, or altered a written instrument, to wit: Town of Parker, Arizona, Check #24205, in violation of A.R.S. §§ 13-2001, 13-2002(A)(1), 13-701, 13-702, and 13-801.

COUNT 4

FORGERY, A CLASS 4 FELONY

JENNIFER ELIZABETH ALCAIDA (001), on or about August 12, 2021, with intent to defraud, falsely made, completed, or altered a written instrument, to wit: Town of Parker, Arizona, Check #24213, in violation of A.R.S. §§ 13-2001, 13-2002(A)(1), 13-701, 13-702, and 13-801.

COUNT 5

FORGERY, A CLASS 4 FELONY

JENNIFER ELIZABETH ALCAIDA (001), on or about August 27, 2021, with intent to defraud, falsely made, completed, or altered a written instrument, to wit: Town of Parker, Arizona, Check #24228, in violation of A.R.S. §§ 13-2001, 13-2002(A)(1), 13-701, 13-702, and 13-801.

COUNT 6

FORGERY, A CLASS 4 FELONY

JENNIFER ELIZABETH ALCAIDA (001), on or about September 1, 2021, with intent to defraud, falsely made, completed, or altered a written instrument, to wit: Town of Parker, Arizona, Check #24229, in violation of A.R.S. §§ 13-2001, 13-2002(A)(1), 13-701, 13-702, and 13-801.

COUNT 7

THEFT, A CLASS 3 FELONY

JENNIFER ELIZABETH ALCAIDA (001), beginning on or about July 14, 2021 and ending on or about July 27, 2021, without lawful authority, knowingly did control the Town of Parker, Arizona's funds, of a value of more than \$4,000 but less than \$25,000, with the intent to deprive the Town of Parker of such property, to wit: \$9,768.00 in cash, in violation of A.R.S. §§ 13-1801, 13-1802(A)(1), 13-701, 13-702, and 13-801.

COUNT 8

FRAUDULENT SCHEMES AND ARTIFICES, A CLASS 2 FELONY

JENNIFER ELIZABETH ALCAIDA (001), beginning or about February 24, 2021 and ending on or about September 21, 2021, pursuant to scheme or artifice to defraud, knowingly did obtain a benefit from the Town of Parker, Arizona, by means of fraudulent pretenses, representation, promises, or material omissions, in violation of A.R.S. §§ 13-2310, 13-701, 13-702, and 13-801.

JENNIFER ELIZABETH ALCAIDA (001) committed fraudulent schemes and artifices by committing the following, including but not limited to: using the Town of Parker's credit cards to pay personal expenses totaling \$4,690.27.

COUNT 9

THEFT, A CLASS 3 FELONY

JENNIFER ELIZABETH ALCAIDA (001), beginning on or about February 24, 2021 and ending on or about September 21, 2021, without lawful authority, knowingly did control the Town of Parker, Arizona's funds, of a value of more than \$4,000 but less than \$25,000, with the intent to deprive the Town of Parker of such property, to wit: \$4,690.27 in credit card expenditures, in violation of A.R.S. §§ 13-1801, 13-1802(A)(1), 13-701, 13-702, and 13-801.


Pursuant to A.R.S. § 21-425, the Grand Jurors find that the offenses described above were committed in Mohave County, Arizona.


