Between about JUNE 1, 2008 and DECEMBER 5, 2008, ALBERT RAY ROBBS, assisted a criminal syndicate by committing any felony offense, whether completed or preparatory, with the intent to promote or further the criminal objectives of a criminal syndicate in violation of A.R.S. §§ 13-2308(C), 13-2301, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, 13-702.01 and 13-801.
