INDICTMENT

Cause No.

The grand jurors of the County of Pima, in the name of the State of Arizona, and by its authority, accuse and charge that in Pima County:

**COUNT 1: VULNERABLE ADULT ABUSE, DOMESTIC VIOLENCE, a Class 2
Felony.**

On or between January 13, 2012 and February 3, 2012, **CHRISTOPHER JOSEPH LOPEZ** intentionally or knowingly caused CYNTHIA FISHER, a vulnerable adult, to suffer physical injury or abuse and/or, having the care or custody of a vulnerable adult, caused or permitted the person or health of the vulnerable adult to be injured and/or caused or permitted the vulnerable adult to be placed in a situation where the person or

1 health of the vulnerable adult was endangered, in violation of A.R.S. §§ 13-3623(A)(1),
2 13-3601, 13-603, 13-701, 13-702, 13-703, 13-704, 13-801, 13-804 and 13-811.

3 Said conduct occurred on or between January 13, 2012 and February 3, 2012,
4 when Christopher Joseph Lopez, who was a paid caregiver for the victim, in Pima
5 County, Arizona, permitted a vulnerable adult to be placed in a situation where the health
6 of the vulnerable adult was endangered.

7 **COUNT 2: VULNERABLE ADULT ABUSE, DOMESTIC VIOLENCE, a Class 4
8 Felony.**

9 On or between April 29, 2012 and May 30, 2012, **CHRISTOPHER JOSEPH
10 LOPEZ** intentionally or knowingly caused CYNTHIA FISHER, a vulnerable adult, to
11 suffer physical injury or abuse and/or, having the care or custody of a vulnerable adult,
12 caused or permitted the person or health of the vulnerable adult to be injured and/or
13 caused or permitted the vulnerable adult to be placed in a situation where the person or
14 health of the vulnerable adult was endangered, in violation of A.R.S. §§ 13-3623(B)(1),
15 13-3601, 13-603, 13-701, 13-702, 13-703, 13-704, 13-801, 13-804 and 13-811.

16 Said conduct occurred on or between April 29, 2012 and May 30, 2012, when
17 Christopher Joseph Lopez, in Pima County, Arizona, permitted a vulnerable adult to be
18 placed in a situation where the health of the vulnerable adult was endangered.
