**I. Call to Order**

Chairperson Ross called the meeting to order at 12:35 p.m. The meeting took place in person at the Office of the Arizona Attorney General, 2005 N. Central Avenue and via Zoom.

**II. Approval of the June 6, 2024 Meeting Minutes**

Chairperson Ross asked if there were any corrections to the minutes. There were no corrections. The June 6, 2024 minutes were approved.

**III. Topics for Discussion and Possible Action**

**1. Appointments to the Subcommittee on Hate-Based Crimes and Antisemitic Incidents**

Chairperson Ross noted that the Board will vote on amendments to the Bylaws in the August meeting, which includes the amendment to appoint non-Board members to subcommittees. Accordingly, no appointments were recommended at this meeting.

**2. Discussion of state legislation relating to national origin and immigration**

Vice Chairperson Mazlum spoke briefly on the topic of a HCR 2060, a ballot initiative, that if passed may impact civil rights in Arizona.

Member Jantz moved to enter Executive Session to consult with counsel pursuant to A.R.S. § 38-431.03(A)(3). Member Ploog seconded the motion. The motion passed unanimously. Admonition was given to the Board.

After the Board resumed its open meeting, Vice Chairperson Mazlum stated he will submit information on the proposed legislation to be circulated to the Board. Vice Chairperson Mazlum will identify individuals who can discuss pending legislation at a future Board meeting. Discussion of HCR will be placed on the August 1, 2024 agenda for discussion and possible action.

#### **IV. Subcommittee Reports and ACRA Events**

**1. Subcommittee on Hate-Based Crimes and Antisemitic Incidents**

Member Ploog, as Chairperson of the Subcommittee, reported that the first Subcommittee meeting was held on June 20, 2024. The Subcommittee adopted a Statement of Purpose and mission. The next meeting will occur on July 12, 2024.

**2. Crime Free Forum**

Member Weinstein-Tull, as co-liaison for the forum, reported that the Board is coordinating with the Division to tentatively schedule the event in August 2024.

**3. Subcommittee to Study and Report on Disability Discrimination in Arizona**

Member Weinstein-Tull, as Chairperson of the Subcommittee, reported that he and the Division are in the process of scheduling the first Subcommittee meeting. Member Jantz offered to provide names of individuals and agencies who may have information for the Subcommittee to consider.
