***Re: Legislative Investigation of Taxpayer-Funded Donations to Nonprofit Organizations; Request for Response***

Dear Mayor Gallego and Councilmembers,

I write to you today, in my official capacity as Chairman of the House Public Safety & Law Enforcement Committee and Representative of Legislative District 7, to learn more about the City of Phoenix's approval process for giving taxpayer-funded monetary donations to nonprofit organizations.

As you may also know, it is my top priority to ensure that Arizona's law enforcement agencies are adequately funded. For example, House Bill (H.B.) 2221, a bill that recently passed out of the House that I sponsored, prohibits cities or towns from reducing their annual operating budgets for a law enforcement agency by any amount below the previous year's budget. I also sponsored and introduced H.B. 2222, which requires legislative approval of costly settlement agreements entered into by cities, towns, and counties, and declares that "due to the impact on public finances, including state finances," those settlement agreements implicate a matter of statewide concern. The People of Arizona are entitled to transparency and financial accountability from their elected officials at all levels of government.

I recently came across the attached flyer for the Arizona Science Center's "Galaxy Gala" held on February 1, 2025. I was shocked to learn that three separate City Departments donated to this Gala for a combined total of **at least \$10,000 for this single event**. To be clear, I do not dispute that it is a worthy cause to support the Science Center's STEM educational programs. But I do question whether it is appropriate for any government body to donate such large sums of taxpayer money to nonprofit organizations outside of a legislatively-authorized grant program—particularly when those funds could be spent on public safety, infrastructure, and other critical city functions.

To that end, I respectfully request a response to the following questions, which will aid me in determining whether to pursue legislative reform:


- How much did the City donate in total to the Galaxy Gala? Please provide specifics, including the dates of each donation and the employee/official from each City Department who approved each donation.
- How many City employees attended the Galaxy Gala? How did the City determine which employees/public officials would attend the Gala?
- What is the City's approval process or written policy governing monetary donations, gifts, and other expenditures for nonprofit organizations or events? Please also explain how long the process or policy has been in existence and provide relevant legal authority supporting such a process or policy.
- How are organizations or fundraisers selected to receive monetary donations from the City of Phoenix?
- Are donations to nonprofit organizations approved by a majority of the City Council members in a meeting open to the public?
- Who is responsible for deciding which organizations to support and what factors are considered in making those decisions?
- Since January 2023, how many nonprofit organizations have received gifts or donations, monetary or otherwise, from the City of Phoenix or any of its departments? Please provide specifics, including the dates of each donation, the name of the organization, and amounts.

Time is of the essence. Please respond to these questions no later than **March 14, 2025**.

Re: Response – *Legislative Investigation of Taxpayer-Funded Donations to Nonprofit Organizations*

Dear Chairman Marshall,

The following information addresses your letter dated February 25, 2025, addressed to Mayor Gallego and the City of Phoenix Councilmembers regarding Legislative Investigation of Taxpayer-Funded Donations to Nonprofit Organizations.

1. How much did the City donate in total to the Galaxy Gala?
  - a. The City sponsored two tables at the Galaxy Gala held on February 1, 2025, at the Arizona Science Center. Each table sponsorship was at the \$5,000 level, with Public Works paying for one table and the Aviation and Water Departments splitting the other table.
2. How many City employees attended the Galaxy Gala? How did the City determine which employees/public officials would attend the Gala?
  - a. The attendees from the City included 13 city staff: managers from the City Manager's Office, Public Works, Water, Aviation, Street Transportation, and Arts and Culture departments. Additionally, Deputy City Manager Ginger Spencer, who serves on the board of directors of the Arizona Science Center, attended as the City's representative. The selection of employees for the event was based on their roles and the departments involved in the event's focus on STEM/STEAM and water education.

- b. The City and the Arizona Science Center (ASC) have worked together to raise awareness and education about recycling, innovation and sustainability in alignment with the ASC's focus on Science, Technology, Engineering and Mathematics (STEM) as well as Science, Technology, Engineering, Arts and Mathematics (STEAM) programming and exhibits. The ASC is also working to develop a new Water educational exhibit focused on water in Arizona. Event table sponsorships ranged from \$5k to \$50k and proceeds benefited ASC's STEM educational programs.
3. What is the City's approval process or written policy governing monetary donations, gifts, and other expenditures for nonprofit organizations or events?
  - a. Phoenix City Code Sec. 2-52 allows for the sponsorship of community events by the City.
  - b. The Aviation Department is an Enterprise Fund Department and statewide economic engine that is required to comply with FAA policies regarding revenue diversion. The Aviation Department ensures adherence to Federal Aviation Administration Revenue Use Policies, specifically 64 FR 30 (1999): 99-3951, Section 5 of the policy that describes permitted uses of airport revenue. The FAA recognizes that contributions for community or charitable purposes can provide a direct benefit to the airport through enhanced community acceptance, but that a benefit of that nature is intangible and not quantifiable. Where the amount of contribution is minimal, the value of the benefit will not be questioned if there is a reasonable connection between the recipient organization and the benefit of local community acceptance for the airport.
4. How are organizations or fundraisers selected to receive monetary donations from the City of Phoenix?
  - a. Organizations are selected based on the alignment of their goals with those of the City department's goals and initiatives. These initiatives are outlined in the performance plans of department directors and management teams and often reflect Council priorities. Additionally, events may be selected for their potential educational or training benefits to City employees. And finally, when the City owns a building and leases it out, as with the Arizona Science Center, that creates a collaborative relationship with the organization.
5. Are donations to nonprofit organizations approved by a majority of the City Council members in a meeting open to the public?
  - a. Donations require approval by the City Council, if a donation is over \$32,000 or more. Department directors have discretion within the approved operating budget for amounts below \$32,000.

6. Who is responsible for deciding which organizations to support and what factors are considered in making those decisions?
  - a. The responsibility for deciding which organizations to support lies with department directors and the City Manager's Office. The factors considered in making these decisions include alignment with the department's goals, Council priorities, and the potential educational or community benefits of the event or organization.
7. Since January 2023, how many nonprofit organizations have received gifts or donations, monetary or otherwise, from the City of Phoenix or any of its departments? Please provide specifics, including the dates of each donation, the name of the organization, and amounts.
  - a. The City does not track donations by nonprofit status. To gather detailed information on nonprofit donations we would need the vendor's names.

Please let us know if further information or clarification is needed.

Dear Ms. Kriegh,

Thank you for your response to my letter dated February 25, 2025, which inquired into the City of Phoenix's policies for donating large sums of taxpayer money to nonprofit organizations. Unfortunately, your response has left me with more questions.

You wrote that Section 2-52 of the Phoenix City Code "allows for the sponsorship of community events by the City," that nonprofit organizations "are selected based on the alignment of their goals with those of the City department's goals and initiatives," and that "Department directors have discretion within the approved operating budget for amounts below \$32,000."

Additionally, when I inquired as to the City's authority underlying this policy, you wrote that the Phoenix City Charter requires City Council approval of "[a]ctions providing for any specific improvement, for the appropriation or expenditure of any public money, except sums less than five thousand (5,000) dollars" and that the City Council may adjust this amount every four years beginning in 1990. You further wrote that this rate "has been adjusted for inflation and is currently \$32,000 and referred to as the 'payment ordinance threshold'" and explained that departments must use "a centralized system" for expenditures under \$32,000.

**Please provide answers to the following questions and submit the documents requested no later than April 1, 2025:**

1. Please submit copies of all relevant Ordinances passed by the Phoenix City Council that increased the payment ordinance threshold from \$5,000 to \$32,000.
2. How many Departments currently exist in the City's organizational structure?
3. How many Department Directors have discretion to sponsor community events or make donations or expenditures of public money below \$32,000?

4. In my initial letter, I asked for details regarding the amounts, dates, and identities of all nonprofit organizations that have received gifts or donations from the City since January 2023. You responded that “[t]he City does not track donations by nonprofit status.” However, you explained that the City utilizes a centralized system where these expenditures must be recorded.
  - a. Please provide a list of all donations and expenditures under \$32,000 that any City Department or Director has made to any person, event, or organization since January 2023.
5. Regarding the Arizona Science Center’s Galaxy Gala, why did Deputy City Manager Ginger Spencer attend the event “as the City’s representative” when she serves on the board of directors at the Arizona Science Center?
  - a. Was a conflict of interest analysis conducted for Ms. Spencer’s attendance at the event?
  - b. Did Ms. Spencer have any role in the City’s approval or decision-making of any part of the \$10,000 donation to the Arizona Science Center for sponsorship of the event tables?
  - c. Does Ms. Spencer supervise, directly or indirectly, any Department Directors? If so, please provide details regarding the chain of command with respect to her position as Deputy City Manager.
  - d. What policies exist at the City or Department level with respect to donations under \$32,000 to avoid perceived or actual conflicts of interest?
6. Has the City undertaken a legal analysis to determine whether the City’s Ordinances/policies governing discretionary expenditures of public money under \$32,000 by Department Directors complies with the Gift Clause under the Arizona Constitution, Arizona’s Open Meeting Laws, and Conflict of Interest laws? If so, please provide me with a copy of the legal analysis.

Thank you for your shared interest in government transparency and accountability.

The Phoenix Online Checkbook shows all expenditures except for payroll related information. It can be filtered and displayed in a number of ways, and the information can be downloaded.

You also asked about Ginger Spencer's attendance at the event. Ms. Spencer's position on the Board is not a paid position. I am not aware of any conflict with the city participating in non-profit events in which a member of staff serves in an unpaid position on a Board. As I am sure you are aware, under Arizona's conflict of interest statutes, only the person who may have a conflict may request a formal legal opinion, which becomes a public record on file with the City Clerk.

**AN ORDINANCE AMENDING SECTION 2-4(B) OF THE  
PHOENIX CITY CODE TO INCREASE THE AUTHORITY  
OF THE CITY MANAGER TO SETTLE CLAIMS AGAINST

WHEREAS, Chapter 4, Section 12 of the Phoenix City Code authorizes the City Council to periodically adjust the amount of public money which may be expended or appropriated,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PHOENIX as follows:

**SECTION 1.** That Section 2-4(b) of the Phoenix City Code is amended to read as follows:

**Sec. 2-4. City Manager--Enforcement of ordinances; distribution of work; settlement of claims.**

(b) The City Manager of the City of Phoenix shall be authorized to appropriate and expend any public money for the City of Phoenix to settle all claims against the City which sum is less than ~~FIVE THOUSAND~~ FIVE THOUSAND SEVEN HUNDRED dollars.

**SECTION 2.** That this amendment shall be effective from and after January 2, 1990.

AN ORDINANCE AMENDING SECTION 2.4(b) OF THE CODE OF THE CITY OF PHOENIX TO INCREASE THE MAXIMUM CLAIM OR EXPENDITURE, WHICH MAY BE PAID BY THE CITY OF PHOENIX WITHOUT A PAYMENT ORDINANCE FROM LESS THAN \$5,700 TO LESS THAN \$8,600.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PHOENIX as follows:

SECTION 1. Section 2-4 (b), Phoenix City Code is amended to read:

**Sec. 2-4.     **City Manager-Enforcement of ordinances; distribution of work; settlement of claims.****

(a) The City Manager shall be empowered and authorized to promulgate regulations concerning the administration and enforcement of the purpose and intent of all existing ordinances of the City and he may, pending the passage of an ordinance, distribute the work of the departments or divisions in the administrative branch and establish temporary divisions.

(b) The City Manager of the City of Phoenix shall be authorized to appropriate and expend any public money for the City of Phoenix to settle all claims against the City which sum is less than ~~five thousand seven hundred EIGHT~~ THOUSAND SIX HUNDRED dollars.

(c) The City Manager, or his representative, shall attend all Council meetings, unless excused by Council. The City Manager, or his representative, shall have the right to take part in discussions, but may not vote.

AN ORDINANCE AMENDING CHAPTER 2, SECTION 2-4, OF THE  
PHOENIX CITY CODE PERTAINING TO THE PAYMENT  
ORDINANCE THRESHOLD.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PHOENIX as  
follows:

SECTION 1. Chapter 2, Phoenix City Code, Section 2-4(B) is amended as  
follows:

**Section 2-4. City Manager authority for the enforcement of  
ordinances; distribution of work; settlement of claims**

- A. The City Manager shall be empowered and authorized to promulgate regulations concerning the administration and enforcement of the purpose and intent of all existing ordinances of the City and he may, pending the passage of an ordinance, distribute the work of the departments or divisions in the administrative branch and establish temporary divisions.
- B. The City Manager of the City of Phoenix shall be authorized to appropriate and expend any public money for the City of Phoenix to settle all claims against the City which sum is less than ~~eight thousand six~~ hundred THIRTY TWO THOUSAND dollars.
- C. The City Manager, or his representative, shall attend all Council meetings, unless excused by Council. The City Manager, or his representative, shall have the right to take part in discussions but may not vote.

SECTION 2. It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses, and words of the City Code are severable, and if any word, clause, sentence, paragraph, or section of the City Code shall be declared unconstitutional or invalid for any reason by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality or invalidity shall not affect any of the remaining words, clauses, sentences, paragraphs, and sections of the City Code, since the same would have been enacted by the City Council without the incorporation in the City of any such unconstitutional or invalid word, clause, sentence, paragraph, or section.

SECTION 3. The amendment set forth above shall be effective September 1, 2023.
