❖ **April 18th: Motivation and Retention in the Forensic Sciences**
David Dawley, PhD **West Virginia University**

The major theme of this session will be to present and discuss conceptual and empirical determinants of employee motivation and retention in the forensic sciences. A concurrent emphasis will be on leadership techniques to improve lab worker job satisfaction, engagement, attachment, and job performance. This session will also include interactive exercises in which attendees will learn how to improve human relations with their employees. Finally, we will use roundtable discussion to identify other critical personnel issues in the forensic science laboratory.

Dr. David Dawley is the Executive Director of the Robbins Center for Global Business and Strategy and an Associate Professor of Management in the College of Business and Economics at West Virginia University. Over the last 20 years, he has earned several College and University-level awards for outstanding teaching and research.

One of David's research interests involves organizational behavior, and more specifically in employee motivation and retention. In this area, his more recent publications have appear in outlets including the Journal of Forensic Science: Policy & Management, Journal of Vocational Behavior, Journal of Social Psychology, Leadership and Organizational Development Journal, Journal of Managerial Issues, Journal of Psychology, International Journal of Leadership Studies, and Career Development International.

Dr. Dawley has worked extensively in the Forensic Science community where he has conducted surveys, training, and provided consulting. David is active in executive education and corporate training. His content areas include strategic planning, motivation, retention, trust, and leadership.
