Volunteer Intern Advocate

To assist advocates as a liaison between victims and members of the criminal justice system by providing mandated victims' rights notification and victim assistance.

Responsibilities

- Answer incoming calls from the general public;
- Provide information and referrals to victims;
- Answer questions regarding the criminal justice process;
- Offer reassurance and empathetic listening;
- Assist Victim Advocates with case work;
- Explain legal rights of victims in layperson's terms;
- · Accompany victims to court;
- Follow-up with victims regarding case status;
- Assist with internal & external commemorative events.

Requirements

Students who are accepted into the internship program must meet the following requirements:

- Commit to a six-month term with OVS;
- Complete approximately 225 hours in the semester (average 9-12 hours per week);
- Complete 24 hours (included in the sixmonth commitment) of advocacy training provided and scheduled by staff;
- · Pass a security background check;
- Possess a valid driver's license or state issued picture ID.

Volunteer Agency Support Team (AST) Intern

To assist the Agency Support Team and its public policy programs in the interest of the furtherance of victims' rights in the AZ criminal justice system.

Responsibilities

- · Coordinate victims' rights presentations;
- · Monitor AZ legislative proposals;
- · Assist with agency grant program;
- Assist with Grant Management System testing;
- · Assist with statewide audit process;
- Manage mandated forms projects;
- Accompany AST team members to meetings, committees, and workgroups;
- Assist with internal & external commemorative events:
- Support the Director and AST staff with special projects.
