



Ashtyn Buechler

Ashtyn Buechler obtained a Bachelor of Science degree in Psychology from the University of Arizona and a Master of Legal Studies degree from Arizona State University. She began her work with the Arizona Attorney General's Office of Victim Services (OVS) as a Volunteer Intern Advocate assisting in the provision of direct services to crime victims during the prosecution phase. Ashtyn was hired as one of the first Special Investigations Victim Advocates in OVS and was integral in building the Investigations-based Victim Assistance Project program to embed advocates to work directly with agents and assist crime victims during investigations. After three years, Ashtyn transferred to the role of the State Victims' Rights Outreach Coordinator, providing education on victims' rights, and then

transitioned to her current role as the State Victims' Rights Funding Administrator, heading up the victims' rights funding program for OVS. Ashtyn is passionate about law and public policy, as well as about making the criminal justice system as fair and effective as possible. She finds great importance in educating others about victims' rights in Arizona and victims' journeys through the criminal justice system

with the hopes of ensuring anyone who works with victims is prepared to provide them with information about their rights and the system as a whole.

State Victims' Rights Compliance Administrator

Ryan Clark

Ryan Clark has been involved in public service for the entirety of his professional career. In 2008 he joined the United States Army as an Infantryman in the 101st Airborne Division. He deployed to Afghanistan one time, where he served as an infantry team leader, company RTO, and was promoted to the rank of Sergeant. After his military service, Ryan completed his Bachelor's Degree in Criminal Justice while also serving as a full-time police officer in Texas. In 2018, he was honored as a regional officer of the year, and in 2020 he was promoted to patrol supervisor and second in command of his agency. Ryan has just over 5,000 hours of professional and course training through the Texas Commission on Law Enforcement, and his experience includes supervision of patrol



operations, investigation of misdemeanor and felony offenses, and he served as chief of police in the chief's absence. Eventually, Ryan's focus shifted, and in Fall of 2021, he began law school at Mitchell Hamline School of Law in St. Paul Minnesota where he currently attends as a 2L. Shortly after beginning law school, Ryan was placed in charge of the victim assistance program for a county attorney's office in Texas. He moved to Phoenix in October of 2022, and in November, the AZ Attorney General's Office of Victim Services welcomed him as the State Victims' Rights Compliance Administrator. In this role, Ryan manages the Victims' Rights Compliance Program and his primary duties include investigating alleged victims' rights violations and ensuring victims' rights compliance through program audits and providing technical assistance to agencies.





Kendall Schaub is currently the State Victims' Rights Outreach Coordinator with the Arizona Attorney General's Office, where she has devoted majority of her professional career. After graduating with a Bachelor of Arts degree in Psychology, as well as both a Bachelor of Science and Master of Science in Criminal Justice all from Arizona State University, Kendall initially embarked on her criminal justice career with the Department of Child Safety as an Investigator. She found herself thoroughly enjoying the more administrative duties of her role, leading to her employment with the Arizona Attorney General's Office of Victim Services (OVS) as the Office Administrator. During her time as the OVS's Office Administrator, Kendall provided great assistance to the Outreach program and became very invested in it. She officially took on the role of State Victims'

Rights Outreach Coordinator in May of 2021. Kendall is extremely passionate in helping others not only learn about state law and public policy, but also teaching better ways to navigate the system. She finds immense satisfaction in life by educating others about victims' rights in Arizona and the criminal justice system. She hopes that those who work in victim services and attend her trainings become better prepared to provide victims with information about their rights and the system as a whole.

State Victims' Rights Outreach Coordinator

Veronica Driz

Veronica Driz obtained a Bachelor of Science degree in Public Management and Policy from the University of Arizona. While pursuing her degree, Veronica sought an internship with the Arizona Attorney General's Office of Victim Services (OVS) as a Volunteer Intern Advocate. She assisted advocates in ensuring crime victims received adequate notice of their rights under Arizona statute. Veronica was hired part-time to cover a vacant caseload while completing her degree and promoted to a full-time Victim Advocate with OVS upon graduation in 2019. Veronica worked with crime victims in the prosecution and post-conviction phases of their cases, including supporting victims in their collection of restitution. Further, she volunteered with the Pima County Attorney's Office as a crisis advocate and has experience collaborating with victims and law enforcement in the immediate



aftermath of a crime. With OVS, Veronica also supervised Volunteer Intern Advocates, during which she found great contentment in

educating college students on the niche of victims' involvement in the criminal justice system. She was recognized in 2021 as a recipient of the Arizona Attorney General "Emerging Star" Award and was nominated in 2022 for the Arizona Prosecuting Attorneys' Advisory Council Advocate of the Year. After several years as an advocate, she transitioned into her current role of State Victims' Rights Outreach Coordinator and remains based in Tucson. Veronica is passionate about interpreting the nuances of policy, problem-solving, and ultimately ensuring victims have a better understanding of the system through the criminal justice professionals they encounter.



The Arizona Attorneys for Criminal Justice (AACJ) filed a petition to amend Rule 39(b)(12) by removing subsections (A) and (B). The petition would remove the requirement that a request for a defense interview, and the response, must go through a prosecutor's office.

As many of you know A.R.S. § 13-4433(B) was ruled unconstitutional in violation of the First Amendment by the US District Court in AACJ et al. v. Brnovich et al., No. CV-17-01422-PHX-SPL (Nov. 2, 20222). Since the judgment, defense attorneys are permitted to directly initiate contact with victims without going through, or notifying, the prosecutor. The judgment did not address the Arizona Rule of Criminal Procedure 39(b)(12) requiring requests for defense interviews to go through the prosecutor. I have heard of confusion from victims, victims' rights providers, prosecutors and defense counsel about what constitutes an interview. The case is not final but the ruling is in effect.

The Arizona Supreme Court has opened the petition for public comment until May 1, 2023, and will consider the petition during its August 2023 Rules Agenda. For information on the petition or to submit a comment visit: https://www.azcourts.gov/Rules
