**ORDER FOR DEFAULT JUDGMENT**

THIS COURT, having received and reviewed the State's Motion for Default Judgment and  
good cause appearing, finds as follows:

IT IS ORDERED that Default Judgment be entered against Defendants Richard Stevens,  
individually; Richard Stevens dba A&D's Auto Care; Richard Stevens and Jane Doe 1, as a marital  
community; Desert Paveing [*sic*], a sole proprietorship; Anthony Stevens, individually; Anthony  
Stevens and Jane Doe 2, as a marital community; David Stevens aka David Lee, individually; David

Stevens and Jane Doe 3, as a marital (hereinafter collectively “Default Defendants”).

IT IS FURTHER ORDERED that Default Defendants pay the State, jointly and severally, the following amounts, with interest thereon at the rate of 4.5% per annum until paid:

\$18,410.00 as restitution;

\$100,000.00 as civil penalties;

\$16,443.00 as the State’s attorney’s fees

\$137.00 as the State’s costs.

Any amounts received by the State pursuant to this Judgment that constitute restitution shall be deposited into the Consumer Restitution and Remediation Revolving Fund, pursuant to A.R.S. § 44-1531.02.

Any amounts received by the State pursuant to this Judgment that constitute attorney’s fees or costs or civil penalties shall be deposited into the Consumer Protection – Consumer Fraud Revolving Fund, established pursuant to A.R.S. § 44-1531.01.

IT IS FURTHER ORDERED that Defendants Richard Stevens, individually; Richard Stevens dba A&D’s Auto Care; Desert Paving, a sole proprietorship; Anthony Stevens, individually; and David Stevens aka David Lee, individually, are permanently enjoined from engaging in any automobile and paving activities in the state of Arizona, from the state of Arizona or to any Arizona resident.
