**COUNT 1: FRAUDULENT SCHEMES AND ARTIFICES,** a Class 2 Felony in violation of A.R.S. §13-2310

COUNT 2: MONEY LAUNDERING IN THE SECOND DEGREE, a Class 3 Felony in violation of A.R.S. §13-2317(B)

COUNTS 3 & 4: COMPUTER TAMPERING: a Class 3 Felony in violation of A.R.S. §13-2316

COUNTS 5 & 7: THEFT, a Class 2 Felony in violation of A.R.S. §13-1802(A)(1)

COUNT 6: VIOLATION OF DUTIES BY A CUSTODIAN OF PUBLIC MONIES, a Class 4 Felony in violation of A.R.S. §35-301

COUNTS 8-40: FORGERY, a Class 4 Felony in violation of A.R.S. §13-2002

The Arizona State Grand Jury accuses **REBECCA M. SIGETI**, charging on this 16th day of October, 2017 that in or from Gila County, Arizona:

#### COUNT 1

## FRAUDULENT SCHEMES AND ARTIFICES

On or between August 1, 2010 and January 31, 2016, defendant, **REBECCA M. SIGETI**, pursuant to a scheme or artifice to defraud, knowingly obtained a benefit from her employers, by means of false or fraudulent pretenses, representations, promises or material omissions and the benefit obtained involved property with a value of \$100,000 or more, in violation of A.R.S. §§ 13-2310, 13-2310(C), 13-2301, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, 13-703, and 13-801.

Said conduct occurred when **REBECCA M. SIGETI** used her position with the Pine-Strawberry Water Improvement District and Sunny Mountain Realty to issue \$841,055 in forged checks payable to herself and businesses that she had access to the bank accounts to then use the funds for her personal expenses.

## **COUNT 2**

## **MONEY LAUNDERING**

On or between July 11, 2010 and January 19, 2016, **REBECCA M. SIGETI** acquired or maintained and interest in, transacted, transferred, transported, received, or concealed the existence or nature of racketeering proceeds knowing or having reason to know that they are the proceeds of an offense A.R.S. §§ 13-2317(B)(1), 13-2301, 13-701, 13-702, 13-801, and 13-811.

Said conduct occurred when REBECCA M. SIGETI concealed the nature of stolen funds by depositing Pine-Strawberry Water District funds into a Sunny Mountain Realty account.

## **COMPUTER TAMPERING**

On or between August 23, 2010 and January 19, 2016, **REBECCA M. SIGETI**, without authority or exceeding authorization of use accessed, altered, damaged or destroyed any computer, computer system or network, with the intent to devise or execute any scheme or artifice to defraud or deceive, or control property or services by means of false or fraudulent pretenses, representation or promises. To wit: Accessed QuickBooks software held by Pine-Strawberry Water Improvement District in violation of A.R.S. §§ 13-2316(A)(1), 13-2301, 13-301, 13-302, 13-303, 13-701, 13-702 and 13-801.

## **COUNT 4**

#### **COMPUTER TAMPERING**

On or between August 10, 2010, and August 31, 2015, **REBECCA M. SIGETI,** without authority or exceeding authorization of use accessed, altered, damaged or destroyed any computer, computer system or network, with the intent to devise or execute any scheme or artifice to defraud or deceive, or control property or services by means of false or fraudulent pretenses, representation or promises. To wit: Accessed QuickBooks software held by Sunny Mountain Realty in violation of A.R.S. §§ 13-2316(A)(1), 13-2301, 13-301, 13-302, 13-303, 13-701, 13-702 and 13-801.

#### COUNT 5

#### THEFT

On or between, August 23, 2010 and January 19, 2016, **REBECCA M. SIGETI**, without lawful authority, knowingly controlled the property of the Pine-Strawberry Water Improvement District with an aggregate value of \$25,000 or more with the intent to deprive the Pine-Strawberry Water Improvement District of such property in violation of A.R.S. §§ 13-1802(A)(1), 13-1802(H), 13-1801, 13-701, 13-702, and 13-801.

Said conduct occurred when **REBECCA M. SIGETI** without lawful authority knowingly controlled \$524,685 in funds that were the property of the Pine-Strawberry Water Improvement District with the intent to deprive them of such property.

## COUNT 6

# VIOLATION OF DUTIES BY A CUSTODIAN OF PUBLIC MONIES

On or between August 23, 2010 and January 19, 2016, **REBECCA M. SIGETI**, a public officer or other person charged with the receipt, safekeeping, transfer or disbursement of public money who, without authority of law, appropriates it, or any portion thereof, to her own use, or the use of another in violation of A.R.S. §§ 35-301(1), 35-302, 13-301, 13-302, 13-303, 13-304, 13-305, 13-306, 13-701, 13-702, 13-801, and 13-811.

Said conduct occurred when **REBECCA M. SIGETI**, a person charged with the receipt, safekeeping, transfer or disbursement of public money appropriated public money held by the Pine-Strawberry Water Improvement District for her own use.

## COUNT 7

## **THEFT**

On or between August 16, 2010, and September 21, 2015, **REBECCA M. SIGETI**, without lawful authority, knowingly controlled the property of Sunny Mountain Realty with an aggregate value of \$25,000 or more with the intent to deprive Sunny Mountain Realty of such property in violation of A.R.S. §§ 13-1802(A)(1), 13-1802(H), 13-1801, 13-701, 13-702, and 13-801.

Said conduct occurred when **REBECCA M. SIGETI** without lawful authority knowingly controlled \$316,370 in funds that were the property of Sunny Mountain Realty with the intent to deprive them of such property.

## **FORGERY**

On or between January 31, 2014 and August 31, 2015, **REBECCA M. SIGETI,** with intent to defraud, offered or presented, whether accepted or not, a forged instrument or one that contains false information, to wit: Sunny Mountain Realty's National Bank of Arizona statements for January 31, 2014, February 28, 2014, March 31, 2014, April 30, 2014, May 30, 2014, June 30, 2014, July 31, 2014, August 29, 2014, September 30, 2014, October 31, 2014, November 28, 2014, March 31, 2015, April 30, 2015, June 30, 2015 July 31,2014 and August of 2015, in violation of A.R.S. §§ 13-2002(A)(3), 13-2002(B), 13-2001, 13-701, 13-702, 13-801, and 13-811.

## COUNT 9

## **FORGERY**

On or about August 23, 2010, **REBECCA M. SIGETI**, with intent to defraud, falsely made, completed or altered a written instrument, to wit: Pine-Strawberry Water improvement District check/warrant #1783 in violation of A.R.S. §§ 13-2002(A)(1), 13-2001, 13-701, 13-702, 13-801, and 13-811.

## COUNT 10

## **FORGERY**
