B. PROBABLE CAUSE STATEMENT

1. Please summarize and include the facts which establish probable cause for the arrest:
SAMUEL HASSAN KUYATEH IS THE EX-BOYFRIEND OF MILLICENT HANCILES. DURING THE TIME OF THEIR COURTSHIP, SAMUEL AND MILLICENT WOULD COMMUNICATE VIA FACETIME/VIDEO CHAT, AND AT TIMES THE COUPLE WOULD TAKE THEIR CLOTHES OFF. UNBEKNOWNST TO MILLICENT, SAMUEL WAS MANIPULATING HIS PHONE TO TAKE SCREEN SHOTS OF THE CONVERSATION. SAMUEL AND MILLICENT WERE INVITED TO A MUTUAL FRIENDS WEDDING, AND BOTH PARTIES BROUGHT A DATE. DURING THIS TIME, SAMUEL BECAME IRATE AND WITNESSES HEARD HIM SAYING THAT HE HAD OBTAINED NUDE PHOTOS OF MILLICENT AND WOULD UPLOAD THEM TO THE GROUP WEDDING CHAT ROOM THAT HAD BEEN CREATED. SOON THEREAFTER, SAMUEL UPLOADED THESE PHOTOS TO THE GROUP WEDDING CHAT ROOM, WHERE AT LEAST 60 PEOPLE SAW THE PHOTOS, DEPICTING A NUDE AND SEMI-NUDE MILLICENT HANCILES. SPECIAL AGENTS FROM THE ARIZONA ATTORNEY GENERALS OFFICE HAVE OBTAINED THE PHOTOS THAT WERE POSTED TO THIS CHATROOM FROM SEVERAL INDIVIDUALS WHO WERE ALSO MEMBERS OF THE CHAT ROOM. UPON REVIEWING THE PHOTOS, SPECIAL AGENTS OBSERVED THE PHOTOS TO DEPICT A FACETIME CONVERSATION WHICH HAD BEEN SCREEN SHOT/CAPTURED. ON THE LARGE PART OF THE SCREEN, A FULLY NUDE FEMALE WAS STANDING, WHICH SHOWED HER BREAST AND AUREOLE AREAS, WHILE A SMALLER SCREEN SHOWED SAMUELS FACE, WHICH IS THE COMMON TECHNICAL DISPLAY FOR FACETIME CONVERSATIONS. WITNESSES WHO CREATED THE CHATROOM PROVIDED VERBAL TESTIMONY THAT SAMUEL WAS KICKED OUT OF THE ROOM ONCE THE IMAGES WERE POSTED, AND DOCUMENTS RECEIVED FROM THE CHAT ROOM COMPANY SUBSTANTIATE THAT TESTIMONY.
