**COUNT 1**

**AGGRAVATED LURING A MINOR FOR SEXUAL EXPLOITATION**

On or about August 17, 2018, **BRYON PAUL WOOD**, with knowledge of the character of the depiction, used an electronic communication device to transmit at least one depiction of material harmful to minors, to wit, image of a penis, for the purpose of initiating or engaging in communication with a recipient who he knew or had reason to know was a minor under the age of 15 years, and by means of that communication, offered or solicited sexual conduct with that person, in violation of A.R.S. §§ 13-3501, 13-3551, 13-3560, 13-701, 13-702, 13-705, and 13-801.

**COUNT 2**

**AGGRAVATED LURING A MINOR FOR SEXUAL EXPLOITATION**

On or about August 21, 2018, **BRYON PAUL WOOD**, with knowledge of the character of the depiction, used an electronic communication device to transmit at least one depiction of material harmful to minors, to wit, image of a penis, for the purpose of initiating or engaging in communication with a recipient who he knew or had reason to know was a minor under the age of 15 years, and by means of that communication, offered or solicited sexual conduct with that person, in violation of A.R.S. §§ 13-3501, 13-3551, 13-3560, 13-701, 13-702, and 13-801.

**COUNT 3**


**ATTEMPTED SEXUAL CONDUCT WITH A MINOR**

On or about August 21, 2018, **BRYON PAUL WOOD**, a person who is at least eighteen years of age, knowingly attempted to engage in sexual intercourse or oral sexual conduct with a person he knew or had reason to know was a minor under age 15, in violation of A.R.S. §13-1001, 13-1401, 13-1405, 13-701, 13-702, 13-705, and 13-801.

Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in Maricopa County, Arizona.
