**COUNT 1**

**ARSON OF A STRUCTURE**

On or about November 1, 2017, **MOHAMED ABDELRAHMAN**, knowingly and unlawfully damaged a structure by knowingly causing a fire or explosion in violation of A.R.S. §§ 13-1701, 13-1703, 13-704, 13-105.13, 13-701, 13-702, and 13-801.

The State further alleges that this offense is a dangerous offense because it involved the discharge, use or threatening exhibition of a deadly weapon or dangerous instrument (to wit: fire), or the intentional or knowing infliction of serious physical injury on another person

**COUNT 2**

**FORGERY**

On or about April 23, 2018, **MOHAMED ABDELRAHMAN**, with the intent to defraud, offered or presented, whether accepted or not, a forged instrument or one that contains false information, in violation of A.R.S. §§ 13-2001, 13-2002, 13-2002(A)(3), 13-701, 13-702, and 13-801

**COUNT 3**

**FRAUDULENT INSURANCE CLAIM**

On or about November 1, 2017, **MOHAMED ABDELRAHMAN**, presented to Liberty Mutual a false or fraudulent claim or proof in support of a claim, upon contract of insurance for payment of any loss in violation of A.R.S. §§ 44-1220, 13-701, 13-702, and 13-801

**COUNT 4**

**FRAUDULENT INSURANCE CLAIM**

On or between November 1, 2017, **MOHAMED ABDELRAHMAN**, presented to Traveler's Insurance Company a false or fraudulent claim or proof in


support of a claim, upon contract of insurance for payment of any loss in violation of A.R.S §§ 44-1220, 13-701, 13-702, and 13-801.
