INDICTMENT

CHARGING VIOLATIONS OF:

COUNT 1: THEFT, Class 3 felony, in violation of A.R.S. § 13-1802

COUNT 2: FRAUDULENT SCHEMES AND ARTIFICES, Class 2 felony, in violation of A.R.S. § 13-2310

COUNT 3: TAMPERING WITH EVIDENCE, Class 6 felony, in violation of A.R.S. § 13-2809(A)(1)

COUNT 4: RECKLESS BURNING, Class 1 misdemeanor, in violation of A.R.S. § 13-1702

The Arizona State Grand Jury accuses **CHRISTY LEE CONLEY**, charging on this 10th day of April, 2018, that in or from La Paz County, Arizona:

COUNT 1
THEFT

On or about between November 27, 2017 and December 19, 2017, **CHRISTY LEE CONLEY**, without lawful authority, knowingly converted for an unauthorized term or use property of Quartzsite Police Department with a value of \$4,000 or more and less than \$25,000, with the intent to deprive Quartzsite Police Department of such property, with a value more than \$4,000 and less than \$25,000, in violation of A.R.S. §§ 13-1801, 13-1802(A)(2), 13-701, 13-702, and 13-801.

COUNT 2
FRAUDULENT SCHEMES AND ARTIFICES

On or about December 19, 2017, **CHRISTY LEE CONLEY**, pursuant to a scheme or artifice to defraud, knowingly obtained a benefit by false or fraudulent pretenses, representation, promises or material omissions, in violation of A.R.S. §§ 13-2310, 13-701, 13-702, and 13-801.

COUNT 3
TAMPERING WITH EVIDENCE

On or about December 19, 2017, **CHRISTY LEE CONLEY**, destroyed, mutilated, altered, concealed or removed physical evidence with the intent to impair its verity or availability with the intent that such physical evidence be unavailable in an official proceeding which was pending or which she knew was about to be instituted, in violation of A.R.S. §§ 13-2809(A)(1), 13-2801, 13-701, 13-702, and 13-801.

COUNT 4
RECKLESS BURNING

On or about December 19, 2017, **CHRISTY LEE CONLEY**, recklessly caused a fire or explosion which resulted in damage to an occupied structure, a structure, wildland or property, in violation of A.R.S. §§ 13-1702, 13-1701, 13-701, 13-702, and 13-801.

Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in La Paz County, Arizona.


