CHARGING VIOLATIONS OF:

**COUNT 1: AGGRAVATED LURING A  
MINOR FOR SEXUAL  
EXPLOITATION**, a Class 2 Felony, in  
violation of A.R.S. §13-3560

**COUNT 2: CHILD SEX  
TRAFFICKING**, a Class 2 Felony, in  
violation of A.R.S. § 13-3212

**COUNT 3: UNLAWFUL AGE  
MISREPRESENTATION**, a Class 3  
Felony, in violation of A.R.S. § 13-3561

**COUNT 4: MONEY LAUNDERING**, a  
Class 3 Felony, in violation of A.R.S. § 13-  
2317

The Arizona State Grand Jury accuses **FRANK LABARBERA JR**, charging on this 4<sup>th</sup> day of September, 2018, that in or from Maricopa County, Arizona:

**COUNT 1**

**AGGRAVATED LURING A MINOR FOR SEXUAL EXPLOITATION**

On or about August 22, 2018 **FRANK LABARBERA JR**, with knowledge of the character of the depiction, used an electronic communication device to transmit at least one depiction of material harmful to minors, to wit, image of a penis, for the purpose of initiating or engaging in communication with a recipient who he knew or had reason to know was a minor under the age of 15 years, and by means of that communication, offered or solicited sexual conduct with that person, in violation of A.R.S. §§ 13-3501, 13-3551, 13-3560, 13-701, 13-702, 13-705, and 13-801.

**COUNT 2**

**CHILD SEX TRAFFICKING**

On or about August 22, 2018, **FRANK LABARBERA JR**, a person who is at least eighteen years of age, knowingly enticed or recruited a minor who he knew or had reason to know was under 15 years of age, with the intent that the minor would engage in prostitution, to wit offering to exchange a phone and clothing for sexual conduct, in violation of A.R.S. §13-3212, 13-3211, 13-701, 13-702, 13-705, and 13-801.

**COUNT 3**

**UNLAWFUL AGE MISREPRESENTATION**

On or about August 21, 2018, **FRANK LABARBERA JR**, a person who is at least eighteen years of age, used an electronic communication device to knowingly misrepresent his age for the purpose of committing a sexual offense, while knowing or having reason to know the

recipient of the communication was a minor, in violation of A.R.S. §13-3501, 13-3561, 13-701, 13-702, 13-705, and 13-801.

**COUNT 4**


**MONEY LAUNDERING**

On or about August 22, 2018, **FRANK LABARBERA JR**, knowingly made property available to another by transaction or transportation knowing that the property was intended to be used to facilitate racketeering, to wit, prostitution, in violation of A.R.S. §13-2317, 13-2301, 13-701, 13-702, 13-705, and 13-801.

Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in Maricopa County, Arizona.
