INDICTMENT

CHARGING VIOLATIONS OF:

**COUNT 1: AGGRAVATED LURING A
MINOR FOR SEXUAL
EXPLOITATION**, a Class 2 Felony, in
violation of A.R.S. §13-3560

**COUNT 2: ATTEMPTED SEXUAL
CONDUCT WITH A MINOR**, a Class 3
Felony, in violation of A.R.S. § 13-1405

**COUNT 3: POSSESSION OF
DANGEROUS DRUGS**, a class 4 Felony in
violation of A.R.S 13-3407

**COUNT 4: POSSESSION OF DRUG
PARAPHERNALIA**, a class 6 Felony, in
violation of A.R.S. 13-3415

The Arizona State Grand Jury accuses **JORDAN DAVID DUNN**, charging on this 4th day of September, 2018, that in or from Maricopa County, Arizona:

COUNT 1

AGGRAVATED LURING A MINOR FOR SEXUAL EXPLOITATION

On or about August 22, 2018 **JORDAN DAVID DUNN**, with knowledge of the character of the depiction, used an electronic communication device to transmit at least one depiction of material harmful to minors, to wit, image of a penis, for the purpose of initiating or engaging in communication with a recipient who he knew or had reason to know was a minor under the age of 15 years, and by means of that communication, offered or solicited sexual conduct with that person, in violation of A.R.S. §§ 13-3501, 13-3551, 13-3560, 13-701, 13-702, and 13-801, in violation of A.R.S. §§ 13-3501, 13-3551, 13-3554, 13-701, 13-702, and 13-801.

COUNT 2

ATTEMPTED SEXUAL CONDUCT WITH A MINOR

On or about August 22, 2018, **JORDAN DAVID DUNN**, a person who is at least eighteen years of age, knowingly attempted to engage in sexual intercourse or oral sexual conduct with a person he knew or had reason to know was a minor under age 15, in violation of A.R.S. §13-1001, 13-1401, 13-1405, 13-701, 13-702, 13-705, and 13-801.

COUNT 3

POSSESSION OF DANGEROUS DRUGS

On or about August 22, 2018, **JORDAN DAVID DUNN**, knowingly possessed methamphetamine, a dangerous drug, in a useable quantity, in violation of A.R.S. 13-3401, 13-3407, 13-701, 13-702, and 12-801

COUNT 4


POSSESSION OF DRUG PARAPHERNALIA

On or about August 22, 2018, **JORDAN DAVID DUNN**, knowingly possessed with the intent to use drug paraphernalia to contain, conceal, inject, ingest, inhale or otherwise introduce into the human body, to wit, meth pipe, in violation of A.R.S. 13-3401, 13-3415, 13-701, 13-702, and 13-801.

Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in Maricopa County, Arizona.
