CHARGING VIOLATIONS OF:

COUNT 1: CHILD SEX TRAFFICKING,
a Class 2 Felony, in violation of A.R.S. § 13-3212

COUNT 2: MONEY LAUNDERING, a
Class 3 Felony, in violation of A.R.S. § 13-2317

The Arizona State Grand Jury accuses **MELQUIADES GARCIE VILLALOBOS**
A.K.A. MELQUIDES GARCIA-VILLALOBOS, charging on this 5th day of September,
2018, that in or from Maricopa County, Arizona:

COUNT 1

CHILD SEX TRAFFICKING

On or about August 28, 2018, **MELQUIADES GARCIE VILLALOBOS A.K.A. MELQUIDES GARCIA-VILLALOBOS** a person who is at least eighteen years of age, knowingly enticed, recruited, harbored, provided, transported, made available to another or otherwise obtained a minor with the intent to cause the minor to engage in prostitution or any sexually explicit performance, who he knew or had reason to know was under 15 years of age, with the intent that the minor would engage in prostitution, to wit offering to exchange money, in violation of A.R.S. §13-3212, 13-3211, 13-701, 13-702, 13-705, and 13-801.

COUNT 2

MONEY LAUNDERING


On or about August 28, 2018, **MELQUIADES GARCIE VILLALOBOS A.K.A. MELQUIDES GARCIA-VILLALOBOS**, knowingly made property available to another by transaction or transportation knowing that the property was intended to be used to facilitate racketeering, to wit, prostitution, in violation of A.R.S. §13-2317, 13-3211, 13-701, 13-702, 13-705, and 13-801.

Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in Maricopa County, Arizona.


