The Arizona State Grand Jury accuses **MORONI AYALA**, charging on this 4th day of
September, 2019, that in or from Maricopa County, Arizona

COUNT 1

LURING A MINOR FOR SEXUAL EXPLOITATION

On or about June 27, 2019, **MORONI AYALA**, offered or solicited sexual conduct with a person knowing or having reason to know the person was a minor under the age of 15 years, in violation of A R S §§ 13-3501, 13-3551, 13-3554, 13-701, 13-702, 13-705, and 13-801

COUNT 2

ATTEMPTED SEXUAL CONDUCT WITH A MINOR

On or about June 27, 2019, **MORONI AYALA** knowingly attempted to engage in sexual intercourse or oral sexual conduct with a minor under the age of 15 years, in violation of A R S §§ 13-1001, 13-1401, 13-1405, 13-701, 13-702, 13-705, and 13-801

COUNT 3

POSSESSION OF DRUG PARAPHERNALIA

On or about June 27, 2019, **MORONI AYALA**, possessed with the intent to use drug paraphernalia, TO WIT hypodermic needle, to plant, propagate, cultivate, grow, harvest, manufacture, compound, convert, produce, process, prepare, test, analyze, pack, repack, store, contain, conceal, inject, ingest, inhale, or otherwise introduce into the human body a drug in violation of Chapter 34 of Title 13, in violation of A R S §13-3415, 13-701, 13-702, 13-707, and 13-801

COUNT 4

POSSESSION OF DRUG PARAPHERNALIA

On or about June 27, 2019, **MORONI AYALA**, possessed with the intent to use drug paraphernalia, TO WIT hypodermic needle, to plant, propagate, cultivate, grow, harvest, manufacture, compound, convert, produce, process, prepare, test, analyze, pack, repack, store,

contain, conceal, inject, ingest, inhale, or otherwise introduce into the human body a drug in violation of Chapter 34 of Title 13, in violation of A R S §13-3415, 13-701, 13-702, 13-707, and 13-801

COUNT 5


POSSESSION OR USE OF DANGEROUS DRUG
