The Arizona State Grand Jury accuses **HECTOR GONZALEZ JR. (001)**, charging on
this 6th day of August, 2019, that in or from Pima County, Arizona:

COUNT ONE
LURING A MINOR FOR SEXUAL EXPLOITATION, A CLASS 3 FELONY

On or about June 13, 2019 through July 29, 2019, **HECTOR GONZALEZ JR. (001)**, offered or solicited sexual conduct, knowing or having reason to know the person was a minor, in violation of A.R.S. §§ 13-3554, 13-301, 13-302, 13-303, 13-304, 13-601, 13-701, 13-705, 13-801, and 13-811.

COUNT TWO
PREPATORY SEXUAL CONDUCT WITH A MINOR, A CLASS 3 FELONY

On or about, June 13, 2019 through July 29, 2019, **HECTOR GONZALEZ JR. (001)**, attempted to knowingly or intentionally engage in sexual intercourse or oral sexual conduct with a child under fifteen years of age, in violation of A.R.S. §§ 13-1001, 13-1405, 13-301, 13-302, 13-303, 13-304, 13-601, 13-701, 13-705, 13-801, and 13-811.


Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in Pima County, Arizona.
