## ATTEMPTED SEXUAL CONDUCT WITH A MINOR

On or about June 25, 2019, **SEAN GRIMES**, a person who is at least eighteen years of age, knowingly attempted to engage in sexual intercourse or oral sexual conduct with a person he knew or had reason to know was a minor at least 15 years of age, in violation of A R S §13-1001, 13-1401, 13-1405, 13-701, 13-702, and 13-801
