The Arizona State Grand Jury accuses **KRISTOFER MARTIN HAAS** charging on this 4th September day of 2019, that in or from Maricopa County, Arizona

COUNT 1

AGGRAVATED LURING A MINOR FOR SEXUAL EXPLOITATION

On or about June 25, 2019 **KRISTOFER MARTIN HAAS**, with knowledge of the character of the depiction, used an electronic communication device to transmit at least one depiction of material harmful to minors, to wit, image of a penis, for the purpose of initiating or engaging in communication with a recipient who he knew or had reason to know was a minor, and by means of that communication, offered or solicited sexual conduct with that person, in violation of A R S §§ 13-3501, 13-3551, 13-3560, 13-701, 13-702, and 13-801

COUNT 2

AGGRAVATED LURING A MINOR FOR SEXUAL EXPLOITATION

reason to know was a minor, and by means of that communication, offered or solicited sexual conduct with that person, in violation of A R S §§ 13-3501, 13-3551, 13-3560, 13-701, 13-702, and 13-801

COUNT 6

ATTEMPTED SEXUAL CONDUCT WITH A MINOR

On or about June 25, 2019 KRISTOFER MARTIN HAAS knowingly attempted to engage in sexual intercourse or oral sexual conduct with a minor, in violation of A R S §§ 13-1401, 13-1405, 13-701, 13-702, 13-705, and 13-801 (HL)

Pursuant to A R S § 21-425, the State Grand Jurors find that the offenses described above were committed in Maricopa County, Arizona
