COUNT 1

LURING A MINOR FOR SEXUAL EXPLOITATION

On or about January 30, 2019, **RAYMOND RICHARD HAMMERS**, offered or solicited sexual conduct with a person knowing or having reason to know the person was a minor under age 15 years, in violation of A R S §§ 13-3501, 13-3551, 13-3554, 13-701, 13-702, 13-705, and 13-801


COUNT 2

ATTEMPTED SEXUAL CONDUCT WITH A MINOR

On or about January 30, 2019, **RAYMOND RICHARD HAMMERS**, a person who is at least eighteen years of age, knowingly attempted to engage in sexual intercourse or oral sexual conduct with a person he knew or had reason to know was a minor under age 15, in violation of A R S §13-1001, 13-1401, 13-1405, 13-701, 13-702, 13-705, and 13-801

Pursuant to A R S § 21-425, the State Grand Jurors find that the offenses described above were committed in Maricopa County, Arizona
