COUNT 1

SOLICITATION TO COMMIT CHILD SEX TRAFFICKING

On or about July 3, 2019, **ANDREW CURTIS HERRINGTON**, with the intent to promote or facilitate the commission of a felony, commanded, encouraged, requested, or solicited another person to entice, recruit, harbor, provide, transport, make available, or otherwise obtain a minor with the intent to cause the minor to engage in prostitution, in violation of A R S §13-3212, 13-3211, 13-3201, 13-1002, 13-701, 13-702, and 13-801

COUNT 2

MONEY LAUNDERING

On or about July 3, 2019, **ANDREW CURTIS HERRINGTON**, attempted to make property available to another by transaction or transportation knowing that the property was intended to be used to facilitate racketeering, TO WIT prostitution, in violation of A R S §13-2317, 13-1001, 13-3211, 13-701, 13-702, and 13-801

COUNT 3


ATTEMPTED SEXUAL CONDUCT WITH A MINOR

On or about July 3, 2019, **ANDREW CURTIS HERRINGTON**, a person who is at least eighteen years of age, knowingly attempted to engage in sexual intercourse or oral sexual conduct with a person he knew or had reason to know was over 15 years of age, in violation of A R S §13-1001, 13-1401, 13-1405, 13-701, 13-702, and 13-801

Pursuant to A R S § 21-425, the State Grand Jurors find that the offenses described above were committed in Maricopa County, Arizona


