The Arizona State Grand Jury accuses **RAUL LOPEZ (001)**, charging on this 29th day of May, 2019, that in or from Santa Cruz County, Arizona:

COUNT ONE
VULNERABLE ADULT ABUSE, A CLASS THREE FELONY

On or about December 20, 2017 through on or about February 13, 2018, **RAUL LOPEZ (001)**, under circumstances likely to produce death or serious physical injury, recklessly caused a vulnerable adult, [REDACTED] to suffer physical injury or having the care or custody of a vulnerable adult, caused or permits the person or health of the vulnerable adult to be injured, or caused the vulnerable adult to be placed in a situation where the person or health of the vulnerable adult was endangered, to wit: PRESSURE ULCER ON LEFT FOOT, in violation of A.R.S. §§ 13-3623, 13-303, 13-603, 13-701, 13-702, 13-801, 13-804, and 13-811.

COUNT TWO
VULNERABLE ADULT ABUSE, A CLASS THREE FELONY

On or about December 20, 2017 through on or about February 13, 2018, **RAUL LOPEZ (001)**, under circumstances likely to produce death or serious physical injury, recklessly caused a vulnerable adult, [REDACTED] to suffer physical injury or having the care or custody of a vulnerable adult, caused or permits the person or health of the vulnerable adult to be injured, or caused the vulnerable adult to be placed in a situation where the person or health of the vulnerable adult was endangered, to wit: PRESSURE ULCER ON RIGHT FOOT, in violation of A.R.S. §§ 13-3623, 13-303, 13-603, 13-701, 13-702, 13-801, 13-804, and 13-811.

COUNT THREE
VULNERABLE ADULT ABUSE, A CLASS FIVE FELONY

On or about December 20, 2017 through on or about February 13, 2018, **RAUL LOPEZ (001)**, under circumstances other than those likely to produce death or serious physical injury, recklessly caused a vulnerable adult, [REDACTED] to suffer physical injury or having the

care or custody of a vulnerable adult, caused or permits the person or health of the vulnerable adult to be injured, or caused the vulnerable adult to be placed in a situation where the person or health of the vulnerable adult was endangered, to wit: PRESSURE ULCER ON HIP, in violation of A.R.S. §§ 13-3623, 13-303, 13-603, 13-701, 13-702, 13-801, 13-804, and 13-811.


COUNT FOUR
VULNERABLE ADULT ABUSE, A CLASS FIVE FELONY

On or about December 20, 2017 through on or about February 13, 2018, **RAUL LOPEZ (001)**, under circumstances other than those likely to produce death or serious physical injury, recklessly caused a vulnerable adult, [REDACTED], to suffer physical injury or having the care or custody of a vulnerable adult, caused or permits the person or health of the vulnerable adult to be injured, or caused the vulnerable adult to be placed in a situation where the person or health of the vulnerable adult was endangered, to wit: PRESSURE ULCER ON BUTTOCKS, in violation of A.R.S. §§ 13-3623, 13-303, 13-603, 13-701, 13-702, 13-801, 13-804, and 13-811.


Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in Santa Cruz County, Arizona.
