## ATTEMPTED SEXUAL CONDUCT WITH A MINOR

On or about July 11, 2019, ROBERT JOHN MACADAM knowingly attempted to engage in sexual intercourse or oral sexual conduct with a minor under the age of 15 years, in violation of A R S §§ 13-1001, 13-1401, 13-1405, 13-701, 13-702, 13-705, and 13-801
