COUNT 1: AGGRAVATED LURING OF A MINOR FOR SEXUAL EXPLOITATION, a Class 2 Felony, in violation of A R S §13-3560

COUNT 2: ATTEMPTED SEXUAL CONDUCT WITH A MINOR, a Class 6 Felony, in violation of A R S § 13-1405

## COUNT 1

AGGRAVATED LURING A MINOR FOR SEXUAL EXPLOITATION

On or between January 29, 2019 and February 6, 2019, HORACIO MENDOZA, knowing the character and content of the depiction, used an electronic communication device to transmit at least one visual depiction of material that is harmful to minors, TO WIT image of a penis, for the purpose of initiating or engaging in communication with a recipient who he knew or had reason to know was a minor at least 15 years old, AND by means of the communication, offered or solicited sexual conduct with that person, in violation of ARS §§ 13-3501, 13-3551, 13-3560, 13-701, 13-702, and 13-801

## COUNT 2

## ATTEMPTED SEXUAL CONDUCT WITH A MINOR

On or between January 29, 2019 and February 6, 2019, HORACIO MENDOZA, a person who is at least eighteen years of age, knowingly attempted to engage in sexual intercourse or oral sexual conduct with a person he knew or had reason to know was a minor at least fifteen years of age, in violation of A R S §13-1001, 13-1401, 13-1405, 13-701, 13-702, and 13-801

Pursuant to ARS § 21-425, the State Grand Jurors find that the offenses described above were committed in Maricopa County, Arizona
