The Arizona State Grand Jury accuses **KENNETH EDWARD NELSON,**

On or between January 24, 2019 and February 20, 2019, **KENNETH EDWARD NELSON**, knowingly distributed, transported, exhibited, received, sold, purchased, electronically transmitted, possessed, or exchanged a visual depiction with email, to wit file titled “tn-Z9MjAF3I 1479242383” with SHA1 Hash Value VKAUOIRDJXDZOAKPUJHVCQAUEK7HNRGT in which a minor under fifteen years of age is engaged in exploitive exhibition or other sexual conduct, in violation of A R S §§ 13-3821, 13-3551, 13-3553, 13-705, 13-702, and 13-801



**SOLICITATION TO COMMIT CHILD SEX TRAFFICKING**


On or between January 24, 2019 and February 14, 2019, **KENNETH EDWARD NELSON**, with the intent to promote or facilitate the commission of a felony, commanded, encouraged, requested or solicited another person to entice, recruit, harbor, provide, transport, make available or otherwise obtain a minor with the intent to cause the minor to engage in prostitution , in violation of A R S §§ 13-1002, 13-3212, 13-3211, 13-3214, 13-701, 13-702, and 13-801


Pursuant to A R S § 21-425, the State Grand Jurors find that the offenses described above were committed in Maricopa County, Arizona
