The Arizona State Grand Jury accuses **TERRI LYNN ROLSTON**, charging on this 9th day of September, 2019, that in or from YAVAPAI County, Arizona:

COUNT 1 – FRAUDULENT SCHEMES AND ARTIFICES

On or between February 15, 2007 through February 15, 2018, **TERRI LYNN ROLSTON**, pursuant to a scheme or artifice to defraud, knowingly obtained a benefit (to wit: unauthorized funds for purported overtime pay) from ORTHOPEDIC SPECIALISTS OF CENTRAL ARIZONA, and/or DR. BURCHFIELD, and/or DR. PIFER, and/or DR. TRAINOR and/or DR. KAPER, by means of fraudulent pretenses, representations, promises or material omissions, in violation of A.R.S. §§ 13-2310, 13-2301, 13-701, 13-702 and 13-801, a class 2 felony.

COUNT 2 – THEFT

On or between February 15, 2007 through February 15, 2018, **TERRI LYNN ROLSTON**, controlled property of ORTHOPEDIC SPECIALISTS OF CENTRAL ARIZONA, and/or DR. BURCHFIELD, and/or DR. PIFER, and/or DR. TRAINOR and/or DR. KAPER to wit: U.S. currency, of a value of twenty-five thousand dollars or more, with the intent to deprive ORTHOPEDIC SPECIALISTS OF CENTRAL ARIZONA, of such property, in violation of A.R.S. §§ 13-1802, 13-1802(H), 13-701, 13-702 and 13-801, a class 2 felony.

COUNT 3 – COMPUTER TAMPERING

On or about February 15, 2007 through February 15, 2018, **TERRI LYNN ROLSTON**, without authority or in excess of her authorization of use, accessed, or

altered a computer, computer system or network, or a part of a computer, computer system or network of ORTHOPEDIC SPECIALISTS OF CENTRAL ARIZONA, with the intent to devise or execute any scheme or artifice to defraud or deceive, or to control property or services by means of a false or fraudulent pretenses, representations or promises , in violation of A.R.S. §§ 13-2316, 13-2301, 13-701, 13-702 and 13-801, a class 3 felony.

COUNT 4 – FRAUDULENT SCHEMES AND ARTIFICES

On or between March 29, 2010 to February 8, 2018, **TERRI LYNN ROLSTON**, pursuant to a scheme or artifice to defraud, knowingly obtained a benefit (to wit: unauthorized funds from forged checks) from ORTHOPEDIC SPECIALISTS OF CENTRAL ARIZONA, and/or DR. BURCHFIELD, and/or DR. PIFER, and/or DR. TRAINOR and/or DR. KAPER, by means of fraudulent pretenses, representations, promises or material omissions, in violation of A.R.S. §§ 13-2310, 13-2301, 13-701, 13-702 and 13-801, a class 2 felony.

COUNT 5 – THEFT

On or between March 29, 2010 to February 8, 2018, **TERRI LYNN ROLSTON**, controlled property of ORTHOPEDIC SPECIALISTS OF CENTRAL ARIZONA, and/or DR. BURCHFIELD, and/or DR. PIFER, and/or DR. TRAINOR and/or DR. KAPER to wit: U.S currency, of a value of twenty-five thousand dollars or more, with the intent to deprive ORTHOPEDIC SPECIALISTS OF CENTRAL ARIZONA, of such property, in

violation of A.R.S. §§ 13-1802, 13-1802(H), 13-701, 13-702 and 13-801, a class 2 felony.

COUNT 6 -- FORGERY

On or about March 29, 2010, **TERRI LYNN ROLSTON**, with intent to defraud, falsely made, completed or altered a written instrument, to wit: check #1220 for \$2,500 purportedly signed by Dr. Burchfield, in violation of A.R.S. §§ 13-2002, 13-701, 13-702 and 13-801, a class 4 felony.

\$3,000 purportedly signed by Dr. Burchfield and Dr. Pifer, in violation of A.R.S. §§ 13-2002, 13-701, 13-702 and 13-801, a class 4 felony.

COUNT 62 -- FORGERY

On or about January 3, 2018, **TERRI LYNN ROLSTON**, with intent to defraud, falsely made, completed or altered a written instrument, to wit: check #1077 for \$1,625 purportedly signed by Dr. Burchfield and Dr. Pifer, in violation of A.R.S. §§ 13-2002, 13-701, 13-702 and 13-801, a class 4 felony.

COUNT 63 -- FORGERY

On or about February 8, 2018, **TERRI LYNN ROLSTON**, with intent to defraud, falsely made, completed or altered a written instrument, to wit: check #1078 for \$2,500 purportedly signed by Dr. Burchfield, with "End of Year Bonus" printed in the memorandum portion, in violation of A.R.S. §§ 13-2002, 13-701, 13-702 and 13-801, a class 4 felony.

Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in YAVAPAI County, Arizona.


