CHARGING VIOLATIONS OF

**COUNT 1: LURING A MINOR FOR  
SEXUAL EXPLOITATION**, a Class 3  
Felony, in violation of A R S §13-3554,

**COUNT 2: ATTEMPTED SEXUAL  
CONDUCT WITH A MINOR**, a Class 3  
Felony, in violation of A R S § 13-1405,

**COUNT 3: UNLAWFUL AGE  
MISREPRESENTATION**, a Class 3

**COUNTS 4-6: ATTEMPTED

The Arizona State Grand Jury accuses ALEX WALDRON, charging on this 5<sup>th</sup> day of  
August 2019, that in or from Maricopa County, Arizona

**COUNT 1**

**LURING A MINOR FOR SEXUAL EXPLOITATION**

On or about June 25, 2019, ALEX WALDRON, offered or solicited sexual conduct with a person knowing or having reason to know the person was a minor under the age of 15 years, in violation of A R S §§ 13-3501, 13-3551, 13-3554, 13-701, 13-702, 13-705, and 13-801

**COUNT 2**

**ATTEMPTED SEXUAL CONDUCT WITH A MINOR**

On or about June 25, 2019, ALEX WALDRON, a person who is at least eighteen years of age, knowingly attempted to engage in sexual intercourse or oral sexual conduct with a person he knew or had reason to know was a minor under age 15, in violation of A R S §13-1001, 13-1401, 13-1405, 13-701, 13-702, 13-705, and 13-801

**COUNT 3**

**UNLAWFUL AGE MISREPRESENTATION**

On or about June 25, 2019, ALEX WALDRON, a person who is at least eighteen years of age and knowing or have reason to know that the recipient of the communication was a minor under the age of 15 years, used an electronic device to knowingly misrepresent the person's age for the purpose of committing any sexual offense involving the recipient listed in A R S § 13-3821(A), TO WIT Sexual Conduct with a Minor and/or Luring a Minor for Sexual Exploitation, in violation of A R S §13-3561, 13-3821, 13-701, 13-702, 13-705, and 13-801

**COUNT 4**

**ATTEMPTED FURNISHING HARMFUL ITEMS TO MINORS**

On or about June 25, 2019, ALEX WALDRON, with knowledge of the character of the item involved, attempted to recklessly furnish, present, provide, make available, give, lend, show, advertise, or distribute to minors any item that was harmful to minors, TO WIT Barely Legal Freshman Year, in violation of A R S §13-1001, 13-3506, 13-701, 13-702, and 13-801

**COUNT 5**

**ATTEMPTED FURNISHING HARMFUL ITEMS TO MINORS**

On or about June 25, 2019, ALEX WALDRON, with knowledge of the character of the item involved, attempted to recklessly furnish, present, provide, make available, give, lend, show, advertise, or distribute to minors any item that was harmful to minors, TO WIT Barely Legal Still in Braces, in violation of A R S §13-1001, 13-3506, 13-701, 13-702, and 13-801

**COUNT 6**

**ATTEMPTED FURNISHING HARMFUL ITEMS TO MINORS**


