CHARGING VIOLATIONS OF

COUNT 1: AGGRAVATED LURING A MINOR FOR SEXUAL EXPLOITATION, a Class 2 Felony, in violation of A R S §13-3560

COUNT 2: ATTEMPTED SEXUAL CONDUCT WITH A MINOR, a Class 3 Felony, in violation of A R S § 13-1405

COUNT 1

AGGRAVATED LURING A MINOR FOR SEXUAL EXPLOITATION

On or about January 29, 2019, **MICHAEL ANDREW WALKER**, knowing the character and content of the depiction, used an electronic communication device to transmit at least one visual depiction of material that is harmful to minors, TO WIT image of a penis, for the purpose of initiating or engaging in communication with a recipient who he knew or had reason to know was a minor under the age of 15 years old, AND by means of the communication, offered or solicited sexual conduct with that person, in violation of ARS §§ 13-3501, 13-3551, 13-3560, 13-701, 13-702, and 13-801

COUNT 2

ATTEMPTED SEXUAL CONDUCT WITH A MINOR

On or about January 29, 2019, **MICHAEL ANDREW WALKER**, a person who is at least eighteen years of age, knowingly attempted to engage in sexual intercourse or oral sexual conduct with a person he knew or had reason to know was a minor under age 15, in violation of ARS §13-1001, 13-1401, 13-1405, 13-701, 13-702, 13-705, and 13-801
