CHARGING VIOLATIONS OF:

COUNT 1: AGGRAVATED LURING A MINOR FOR SEXUAL EXPLOITATION, a Class 2 Felony, in violation of A.R.S. §13-3560

COUNT 2: ATTEMPTED SEXUAL CONDUCT WITH A MINOR, a Class 3
Felony, in violation of A.R.S. § 13-1405

The Arizona State Grand Jury accuses **BRANDON ALLEN WYCOFF**, charging on this 4th day of March, 2019, that in or from Maricopa County, Arizona:

COUNT 1

AGGRAVATED LURING A MINOR FOR SEXUAL EXPLOITATION

On or about January 29, 2019, **BRANDON ALLEN WYCOFF**, knowing the character and content of the depiction, used an electronic communication device to transmit at least one visual depiction of material that is harmful to minors, TO WIT: image of a penis, for the purpose of initiating or engaging in communication with a recipient who he knew or had reason to know was a minor under the age of 15 years old, AND by means of the communication, offered or solicited sexual conduct with that person, in violation of A.R.S. §§ 13-3501, 13-3551, 13-3560, 13-701, 13-702, and 13-801.

COUNT 2

ATTEMPTED SEXUAL CONDUCT WITH A MINOR

On or about January 29, 2019, **BRANDON ALLEN WYCOFF**, a person who is at least eighteen years of age, knowingly attempted to engage in sexual intercourse or oral sexual conduct with a person he knew or had reason to know was a minor under age 15, in violation of A.R.S. §13-1001, 13-1401, 13-1405, 13-701, 13-702, 13-705, and 13-801.

Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in Maricopa County, Arizona.
