CHARGING VIOLATIONS OF:

**COUNTS 1-10: SEXUAL
EXPLOITATION OF A MINOR, Class 2
Felonies and Dangerous Crimes Against
Children, in violation of A.R.S. § 13-3553.**

The State Grand Jury for the State of Arizona accuses **EDWARD CLARENCE ELDER**, charging on this 29th day of July, 2019, that in or from Maricopa County, Arizona:

COUNT 1
SEXUAL EXPLOITATION OF A MINOR

On or about July 19, 2019, **EDWARD CLARENCE ELDER**, knowingly distributed, transported, exhibited, received, sold, purchased, electronically transmitted, possessed, or exchanged a visual depiction, TO WIT: tmp-27BINStzVnEmUo, in which a minor under fifteen years of age is engaged in exploitive exhibition or other sexual conduct, in violation of A.R.S. §§ 13-3821, 13-3551, 13-3553, 13-705, 13-702, and 13-801.

COUNT 2

SEXUAL EXPLOITATION OF A MINOR

On or about July 19, 2019, **EDWARD CLARENCE ELDER**, knowingly distributed, transported, exhibited, received, sold, purchased, electronically transmitted, possessed, or exchanged a visual depiction, TO WIT: tmp-27D7t8H8c1FiA6, in which a minor under fifteen years of age is engaged in exploitive exhibition or other sexual conduct, in violation of A.R.S. §§ 13-3821, 13-3551, 13-3553, 13-705, 13-702, and 13-801.

COUNT 3

SEXUAL EXPLOITATION OF A MINOR

On or about July 19, 2019, **EDWARD CLARENCE ELDER**, knowingly distributed, transported, exhibited, received, sold, purchased, electronically transmitted, possessed, or exchanged a visual depiction, TO WIT: tmp-27D28tFCKaryAj, in which a minor under fifteen years of age is engaged in exploitive exhibition or other sexual conduct, in violation of A.R.S. §§ 13-3821, 13-3551, 13-3553, 13-705, 13-702, and 13-801.

COUNT 4

SEXUAL EXPLOITATION OF A MINOR

On or about July 19, 2019, **EDWARD CLARENCE ELDER**, knowingly distributed, transported, exhibited, received, sold, purchased, electronically transmitted, possessed, or exchanged a visual depiction, TO WIT: tmp-271bEbNP3EoCOZ, in which a

minor under fifteen years of age is engaged in exploitive exhibition or other sexual conduct, in violation of A.R.S. §§ 13-3821, 13-3551, 13-3553, 13-705, 13-702, and 13-801.

COUNT 5

SEXUAL EXPLOITATION OF A MINOR

On or about July 19, 2019, **EDWARD CLARENCE ELDER**, knowingly distributed, transported, exhibited, received, sold, purchased, electronically transmitted, possessed, or exchanged a visual depiction, TO WIT: tmp-27NGUH0QV5V6Tz, in which a minor under fifteen years of age is engaged in exploitive exhibition or other sexual conduct, in violation of A.R.S. §§ 13-3821, 13-3551, 13-3553, 13-705, 13-702, and 13-801.

COUNT 6

SEXUAL EXPLOITATION OF A MINOR

On or about July 19, 2019, **EDWARD CLARENCE ELDER**, knowingly distributed, transported, exhibited, received, sold, purchased, electronically transmitted, possessed, or exchanged a visual depiction, TO WIT: tmp-27I15motCJvhfO, in which a minor under fifteen years of age is engaged in exploitive exhibition or other sexual conduct, in violation of A.R.S. §§ 13-3821, 13-3551, 13-3553, 13-705, 13-702, and 13-801.

COUNT 7

SEXUAL EXPLOITATION OF A MINOR

On or about July 19, 2019, **EDWARD CLARENCE ELDER**, knowingly distributed, transported, exhibited, received, sold, purchased, electronically transmitted, possessed, or exchanged a visual depiction, TO WIT: tmp-27xBj663FBLnW3, in which a minor under fifteen years of age is engaged in exploitive exhibition or other sexual

conduct, in violation of A.R.S. §§ 13-3821, 13-3551, 13-3553, 13-705, 13-702, and 13-801.

COUNT 8

SEXUAL EXPLOITATION OF A MINOR

On or about July 19, 2019, **EDWARD CLARENCE ELDER**, knowingly distributed, transported, exhibited, received, sold, purchased, electronically transmitted, possessed, or exchanged a visual depiction, TO WIT: tmp-27xZ0h45Q1mR4Z, in which a minor under fifteen years of age is engaged in exploitive exhibition or other sexual conduct, in violation of A.R.S. §§ 13-3821, 13-3551, 13-3553, 13-705, 13-702, and 13-801.

COUNT 9

SEXUAL EXPLOITATION OF A MINOR

On or about July 19, 2019, **EDWARD CLARENCE ELDER**, knowingly distributed, transported, exhibited, received, sold, purchased, electronically transmitted, possessed, or exchanged a visual depiction, TO WIT: tmp-272TFU1zZx7Rhv, in which a minor under fifteen years of age is engaged in exploitive exhibition or other sexual conduct, in violation of A.R.S. §§ 13-3821, 13-3551, 13-3553, 13-705, 13-702, and 13-801.

COUNT 10


SEXUAL EXPLOITATION OF A MINOR

On or about July 19, 2019, **EDWARD CLARENCE ELDER**, knowingly distributed, transported, exhibited, received, sold, purchased, electronically transmitted, possessed, or exchanged a visual depiction, TO WIT: tmp-276rwaXZ9y2eOP, in which a minor under fifteen years of age is engaged in exploitive exhibition or other sexual conduct, in violation of A.R.S. §§ 13-3821, 13-3551, 13-3553, 13-705, 13-702, and 13-801.

Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in Maricopa County, Arizona.
