In May 2018, a settlement was reached between my office and certain Volkswagen, Audi, and Porsche entities and an individual associated with those entities (collectively “VW”)¹ related to the marketing, advertising, selling, and leasing of certain Volkswagen, Audi, and Porsche “clean diesel” vehicles for model years 2009-2016 (“Covered Conduct”). Records indicate that you may have owned or leased one of these vehicles – a Model Year: <<ModelYear>>, Make: <<Make>>, VIN: <<VIN>> -- on the relevant date.

You submitted a Claim Form in connection with this settlement. After review of your Claim Form to confirm eligibility, my office is pleased to provide the enclosed check, which reflects <<IssueAmount>> payment as restitution for a loss in value sustained with respect to the above-referenced vehicle as a result of the Covered Conduct. This payment is in addition to any other amounts you may have received from other settlements relating to the “clean diesel” vehicles.

Cashing this check does not release any claims you may still have against VW, but VW may assert the amount offered to you in this check as an offset in any pending or future litigation by you against VW, whether you cash it or not. No tax forms will be sent to you as a result of your receipt of this payment; however, the fact that we are not required to issue Forms 1099 does not affect nor imply the tax consequences of the payment in your hands. The payment may constitute income to you, in whole or in part, based on your individual circumstances. **THE INFORMATION CONTAINED HEREIN IS NOT AND SHOULD NOT BE RELIED UPON AS TAX ADVICE. CONSULT YOUR TAX ADVISOR WITH RESPECT TO THE SPECIFIC TAX CONSEQUENCES OF THE PAYMENT TO YOU.**
