The Attorney General of the State of Arizona accuses, **JESSE ANTHONY GARCIA (001)**, charging that in Maricopa County, Arizona:

COUNT 1

SEXUAL EXPLOITATION OF A MINOR

On or about February 22, 2016, **JESSE ANTHONY GARCIA** knowingly recorded, filmed, photographed, developed, or duplicated a visual depiction in which a minor is engaged in exploitative exhibition or other sexual conduct, said minor being under fifteen years of age, in violation of A.R.S. §§ 13-3551, 13-3553, 13-705, 13-3821, 13-610, 13-702, and 13-801.

This conduct occurred when **JESSE ANTHONY GARCIA** created a graphic image with the file name “trim – copy.mp4”.

COUNT 2

SEXUAL EXPLOITATION OF A MINOR

On or about April 4, 2016, **JESSE ANTHONY GARCIA** knowingly recorded, filmed, photographed, developed, or duplicated a visual depiction in which a minor is engaged in exploitative exhibition or other sexual conduct, said minor being under fifteen years of age, in violation of A.R.S. §§ 13-3551, 13-3553, 13-705, 13-3821, 13-610, 13-702, and 13-801.

This conduct occurred when **JESSE ANTHONY GARCIA** created a graphic image with the file name “trim.F – copy.mp4”.

COUNT 3

SEXUAL EXPLOITATION OF A MINOR

During a period of time beginning on or about February 22, 2016, and ending on or about April 4, 2016, **JESSE ANTHONY GARCIA** knowingly recorded, filmed, photographed, developed, or duplicated a visual depiction in which a minor is engaged in exploitative exhibition or other sexual conduct, said minor being under fifteen years of age, in violation of A.R.S. §§ 13-3551, 13-3553, 13-705, 13-3821, 13-610, 13-702, and 13-801.

This conduct occurred when **JESSE ANTHONY GARCIA** created a graphic image with the file name “Image (2).jpeg”.

COUNT 4

SEXUAL EXPLOITATION OF A MINOR

During a period of time beginning on or about February 22, 2016, and ending on or about April 4, 2016, **JESSE ANTHONY GARCIA** knowingly recorded, filmed, photographed, developed, or duplicated a visual depiction in which a minor is engaged in exploitative exhibition or other sexual conduct, said minor being under fifteen years of age, in violation of A.R.S. §§ 13-3551, 13-3553, 13-705, 13-3821, 13-610, 13-702, and 13-801.

This conduct occurred when **JESSE ANTHONY GARCIA** created a graphic image with the file name "image.jpeg".

COUNT 5

SEXUAL EXPLOITATION OF A MINOR

During a period of time beginning on or about February 22, 2016, and ending on or about April 4, 2016, **JESSE ANTHONY GARCIA** knowingly recorded, filmed, photographed, developed, or duplicated a visual depiction in which a minor is engaged in exploitative exhibition or other sexual conduct, said minor being under fifteen years of age, in violation of A.R.S. §§ 13-3551, 13-3553, 13-705, 13-3821, 13-610, 13-702, and 13-801.

This conduct occurred when **JESSE ANTHONY GARCIA** created a graphic image with the file name "Image(6).jpeg".

COUNT 6

SEXUAL EXPLOITATION OF A MINOR


