COUNT 1: FRAUDULENT SCHEMES AND ARTIFICES, a class 2 felony, in violation of A.R.S. §13-2310

COUNT 2: ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG, Class 3 Felony, in violation of A.R.S. §§13-3408

COUNT 3: ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG, Class 3 Felony, in violation of A.R.S. §§13-3408

COUNT 4: ILLEGAL ADMINISTRATION OF A DANGEROUS DRUG, Class 3 Felony, in violation of A.R.S. §§13-3408

COUNT 5: ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG, Class 3 Felony, in violation of A.R.S. §§13-3408

The Arizona State Grand Jury accuses **JAMES BARSZ** charging on this 10TH day of February, 2020, that in or from Pinal County, Arizona:

COUNT 1: FRAUDULENT SCHEMES AND ARTIFICES

On or between August 1, 2018 and July 1, 2019, **JAMES BARSZ**, pursuant to a scheme or artifice to defraud, knowingly obtained a benefit (to wit: money) by means of fraudulent pretenses, representations, promises or material omissions, in violation of A.R.S. §§ 13-2310, 13-2301, 13-603, 13-610, 13-701, 13-702, 13-801, 13-804, 13-301 and 13-811.

COUNT 2: ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG

On or about May 14, 2019, **JAMES BARSZ**, knowingly administered a narcotic drug (to wit: Buprenorphine) to another person (James Younger) in violation of A.R.S. §§13-3408(A)(5), 13-3401, 13-603, 13-610, 13-701, 13-702, 13-703, 13-801, 13-804, 13-301 and 13-811.

COUNT 3: ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG

On or about May 14, 2019, **JAMES BARSZ**, knowingly administered a narcotic drug (to wit: Morphine) to another person (Kristen Schlagel) in violation of A.R.S. §§13-3408(A)(5), 13-3401, 13-603, 13-610, 13-701, 13-702, 13-703, 13-801, 13-804, 13-301 and 13-811.

COUNT 4: ILLEGAL ADMINISTRATION OF A DANGEROUS DRUG

On or about May 19, 2019, **JAMES BARSZ**, knowingly administered a narcotic drug (to wit: Dexroamphetamine-amphetamine) to another person (Brittney Curdie) in violation of A.R.S.

§§13-3408(A)(5), 13-3401, 13-603, 13-610, 13-701, 13-702, 13-703, 13-801, 13-804, 13-301 and 13-811.

COUNT 5: ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG


On or about May 28, 2019, **JAMES BARSZ**, knowingly administered a narcotic drug (to wit: Buprenorphine) to another person (Robert Mathews) in violation of A.R.S. §§13-3408(A)(5), 13-3401, 13-603, 13-610, 13-701, 13-702, 13-703, 13-801, 13-804, 13-301 and 13-811.

COUNT 6: ILLEGAL ADMINISTRATION OF A NARCOTIC DRUG

On or about June 5, 2019, **JAMES BARSZ**, knowingly administered a narcotic drug (to wit: Methadone) to another person (Craig Odell) in violation of A.R.S. §§13-3408(A)(5), 13-3401, 13-603, 13-610, 13-701, 13-702, 13-703, 13-801, 13-804, 13-301 and 13-811.

Pursuant to A.R.S. § 21-425, the State Grand Jurors find that the offenses described above were committed in Pinal County, Arizona.


