**COUNT 1**

**FAILURE TO REPORT**

Between August 1, 2018 and December 31, 2018, **JOSHUA ANTHONY BRIBIESCAS**, a school personnel with Dobson High School in Mesa, Arizona having reason to believe that a minor, A L , had been the victim of a reportable offense(s) to-wit Sexual Conduct with a Minor and/or Sexual Abuse failed to immediately report or cause

reports to be made to a peace office or to the department of child safety, in violation of § 13-3620, 13-1405, 13-1404, 13-1401, 13-701, 13-702, and 13-801

**COUNT 2**  
**FAILURE TO REPORT**

Between September 1, 2018 and December 31, 2018, **JOSHUA ANTHONY BRIBIASCAS**, a school personnel with Dobson High School in Mesa, Arizona having reason to believe that a minor, A H , had been the victim of a reportable offense(s) to-wit Sexual Conduct with a Minor and/or Sexual Abuse failed to immediately report or cause reports to be made to a peace office or to the department of child safety, in violation of § 13-3620, 13-1405, 13-1404, 13-1401, 13-701, 13-702, and 13-801

Pursuant to A R S § 21-425, the State Grand Jurors find that the offenses described above were committed in Maricopa County, Arizona
