COUNT 2

MONEY LAUNDERING IN THE SECOND DEGREE

On or between September 20, 2017 and April 3, 2019, **GRETEL DE LA FUENTE GAMEZ (001)** and **BEJAR ABDULAZIZ (002)**, acquired or maintained an interest in, transacted, transferred, transported, received, or concealed the existence or nature of racketeering proceeds knowing or having reason to know that they were proceeds of an offense, **TO WIT FRAUDULENT SCHEMES AND ARTIFICES**, in violation of A R S §§ 13-2317(B)(1), 13-2301, 13-301, 13-302, 13-303, 13-304, 13-701, 13-702, and 13-801

COUNT 3

ILLEGALLY CONDUCTING AN ENTERPRISE

A On or between September 20, 2017 and April 3, 2017, **GRETEL DE LA FUENTE GAMEZ (001)** and **BEJAR ABDULAZIZ (002)**, defendants herein, employed by or associated with an enterprise, did knowingly conduct such enterprise's affairs through racketeering or did knowingly participate directly or indirectly in the conduct of the enterprise which they knew was being conducted through racketeering

B The enterprise was a group of persons associated in fact, including but not limited to **GRETEL DE LA FUENTE GAMEZ (001)** and **BEJAR ABDULAZIZ (002)**,

C The racketeering included

- 3) **SALE OR TRANSPORTATION OF A NARCOTIC DRUG (COCAINE)**, a Class 2 Felony, in violation of A R S § 13-3408
- 4) **SALE OR TRANSPORTATION OF A NARCOTIC DRUG (CANNABIS)**, a Class 2 Felony, in violation of A R S § 13-3408




